The Tehsil Municipal Administration Khanpur has received funds from Government of Khyber Pakhtunkhwa. Therefore, Tehsil Municipal Administration Khanpur intends to purchase the following solid waste machinery from the well-reputed and experience Manufacturers/Fabricators (Only) having NTN, GST, and 3S facility i.e. Sale, Service & Spare parts in Khyber Pakhtunkhwa. The E-bids are invited under single stage – **two envelope method of KPPRA Rules 2014** (Technical and Financial).

Following are the terms & conditions: -

1. Registration & Online Submission: Interested and eligible bidders/contractors duly registered on the EPAD link (<https://kp.eprocure.gov.pk/#/supplier/registration>) are eligible to apply. Technical and Financial bids must be uploaded online on the EPADS portal strictly in accordance with the prescribed procedure of KPPRA.
2. Physical Submission of Bids: Sealed bids (containing separate sealed envelopes for Technical and Financial bids) must be submitted through registered mail or postal service. No bid forms or manual hand-deliveries will be entertained. Bids must reach the office of the undersigned by 20/07/2026 no later than 11:00 AM.
3. Bid Opening Schedule: Technical Bids shall be opened on the same date (20/07/2026) at 12:30 PM in the presence of the bidders or their authorized representatives by the TMA Tender Committee.
4. Bid Security (CDR): An original Bid Security equal to two percent (2%) of the total bid price in the shape of a Call Deposit Receipt (CDR) from a scheduled bank in the name of "TMO TMA KHANPUR" must be sealed and enclosed strictly within the Technical Bid envelope. Financial bids without the original CDR in the technical envelope or with deficient bid security shall be rejected on the spot.
5. Evaluation Process: The procuring entity shall evaluate the technical proposals as per the criteria prescribed in the bidding documents. Financial bids of only technically responsive/qualified bidders shall be opened publicly at a date and time to be communicated later through EPADS and registered emails. Financial bids of technically non-responsive bidders will be returned unopened.
6. Signing of Documents: All pages of the Technical and Financial Bids must be duly signed and stamped by the authorized representative of the bidder before uploading on EPADS and physical submission.
7. Taxation & Levies: All applicable federal and provincial taxes, including Sales Tax (FBR), Income Tax, KPRA infrastructure/services taxes, and stamp duties etc., as per prevailing Government Rules, shall be deducted from the bills.
8. Pricing Basis: All rates shall be quoted on a Firm-Object-Rate (FOR) basis with free supply, fabrication, and delivery to the premises of the TMA Khanpur office.
9. Warranty & Training: The successful bidder shall provide a minimum of 01-year comprehensive warranty for the fabricated machinery/structures and shall provide complete operational training to the TMA staff at their own expense.
10. Non-Blacklisting Affidavit: Bidders must enclose a judicial stamp paper affidavit (worth Rs. 100/- minimum) certifying that the firm is not blacklisted, suspended, or in litigation with any Government, Semi-Government, or Autonomous body.
11. Disqualification Criteria: Incomplete, conditional, late-submitted, or manually handed-over bids shall not be accepted/entertained under any circumstances.

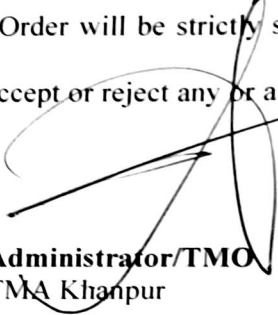
