TERMS AND CONDITIONS.

1. Bid Solicitation Documents (BSD), which includes Bill of Quantity, Criteria and other data/information, can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The bidder shall submit/upload the bids (by file uploading) through EPADS before last date and time for submission of bid.
3. The bidder shall only submit, physically, their original bid security (ies)/additional security (ies) (in the shape of call deposit receipt made in favour of the undersigned) in the office of the undersigned through registered post/ courier before last date and time for bid submission.
4. Last date & Time of submission of the bid is **20-07-2026 at 11:00 A.M (on EPADS)** and received technical bid(s) shall be opened (downloaded from EPADS) on **20-07-2026 at 11:30 A.M** in the presence of bidders or their representatives who opt to be present.
5. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
6. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.
7. The bidders shall submit their bids as per KP-PPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10/05/2022 and KP-PPRA's Notification No. S.R.D.(29)/Vol:1-40/2025-26/699-711 dated 29/10/2025 shall be applicable.

9. The 2% bid security should be accompanied by Stamp Duty & 0.03 % Bidding Fees. In case of non-submission, the bid will be considered as Non-responsive.
