

DISPOSAL OF ASSETS OF ROAD TRANSPORT BOARD, KHYBER PAKHTUNKHWA

1. The Road Transport Board (RTB) Khyber Pakhtunkhwa invites sealed bids under rule 6 (2) (a) "Single Stage One Envelope Procedure" of KPPRA Rules 2014, from eligible bidders for the disposal of its assets namely; (a) Collection of Adda Fees of Peshawar Bus Terminal, (b) Canteen & Tuck Shop, (c) Mobile/Computer Accessories Shop, (d) Spare Parts Shop, (e) Photostat/Easypaisa Shop, and (f) Cleanliness of Washrooms of Peshawar Bus Terminal (PBT), under the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Act 2012 read with Rule No. 50D of KPPRA Rules 2014.
