2. All bidders/contractors must have registration with Khyber Pakhtunkhwa Revenue Authority (KPPRA) & PEC with active status and having codes i.e CE-09 for civil and EE-04, EE-05, EE-11, and ME-07 for repair of Electric Machinery and Solar Works, otherwise his bid will be considered non-responsive.
3. The last date and time of submission of electronic tender form is 20.07.2026, 12:00 Noon.
4. The date and time of opening is 20.07.2026, 12:30 Noon.
5. The bidder shall submit/upload the bids [by file uploading] through EPADS before last date and time for submission of bid.
6. The bidder shall submit, physically, their original bid security(ies)/additional security(i.es), tender form fees (in the shape of call deposit receipt made in favour of the undersigned) in the office of the undersigned through registered post/courier before last date and time for bid submission.
7. The received bids shall be opened (downloaded from EPADS) on/after the date and time for opening of bids in the presence of bidders or their representatives who opt to be present.
8. The bidders should submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
9. Clarifications/queries, if any, shall be asked/communicated through EPADS.
10. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non-responsive".
