- The tender form will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
 - While the original tender form along with original bid securities i.e. 2% earnest money and additional CDR (if applicable) and detailed rate analysis (if applicable) complete in all respect must be delivered before closing hours through courier to the office of Tehsil Officer (Infrastructure), TMA Balakot.
 - The last time and date for online clarification is upto 05:00 PM on 20-07-2026.
 - The bid securities shall be in the shape of call deposit receipt in favor of the TMO, TMA Balakot.
 - In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture.
 - The contractor or his representative can be present at time of opening of electronic bids.
 - The call deposits i.e. bid security for the work contract must be prepared after publishing of NIT and before closing time of the bid apply.
 - In case of tie draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
 - The bidder shall have the relevant codes as per Pakistan Engineering Council against each mentioned work.
 - All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under the Khyber Pakhtunkhwa Finance Act 2013.
 - The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e: Tender Form, BOQ duly signed and stamped, SBDs, Fresh LCB Registration, CNIC copy, Active NTN Income Tax certificate, Valid PEC License upto 2026, Active fresh KPPRA Registration.
 - The quoted rate must be clearly mentioned in words and figures on tender form. Incomplete over-writing/ disfiguring will not be acceptable and any mismatching, materially inaccurate, incomplete or failure to send information in hard form among the scanned copies submitted through EPADS will lead to disqualification and considered as non-responsive as per KPPRA rules.
 - The firms/contractors who want to participate in tendering process must be registered themselves with the EPADS for gaining their unique username and password.
 - All material testing and all sorts of tests will be performed by contractor on the demand of procuring entity at the cost and risk of the contractor.
 - The Bid Security and Additional Security shall be submitted as per KPPRA Notification No. S.R.O(14)/Vol:1-24/2021-22/6058-71 dated 10-05-2022.
 - As per KPPRA Notification No. S.R.O(29)/Vol:1-40/2025-26/699-711 dated 29-10-2025, bidders are required to enter detail of bid security and additional security in EPADS and the same shall be submitted to the procuring entity well before closing time and date and the same will be retained by the procuring entity until the award of contract or bid validity whichever come first. Failure to do so action will be carried out as per the mentioned notification.
 - In case the contractor is not successful, then 2% call deposit & additional securities (if any) will be refunded after signing the agreement with successful bidder and the department.
 - Work order will be issued on availability of 100% funds with Tehsil Municipal Administration Balakot.
 - The Authority reserves the right to cancel single or all schemes without assigning any reason.
