Peshawar Development Authority (PDA), invites sealed bids through EPADS, from the eligible contractors / firms in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 on "Single Stage Two envelope system" under Rule 14(2)(b), on percentage above/ below on BOQ/ Engineer cost estimate (MRS-2025) for the following works. The bidder shall be registered with: (i) e-Pak Acquisition and Disposal System (EPADS) (ii) Pakistan Engineering Council (PEC) for the year 2025-2026 (iii) Khyber Pakhtunkhwa Revenue Authority (KPRA) (active) (iv) Federal Board of Revenue (FBR) (NTN active) (v) Enlisted with PDA/Provincial Enlistment committee KP for the current year and having sufficient experience in the field of work given below:

TERMS & CONDITIONS

The bidders are advised to read and understand the criteria provided in the Bid Solicitation Documents (BSDs) for mandatory and other requirements.

1. The eligible constructors / firms / contractors can obtain Sample tender form, Bid Solicitation Documents including Evaluation Criteria / Bidding or Contract Data / BOQ from the official website of EPADS <https://www.eprocure.gov.pk/>.
2. Pre-bid meeting will be held on 20/07/2026 at 1400 Hours in the office of Director Engineering Roads-I, PDA.
3. The bidders shall submit / upload their Technical and Financial bids [by file uploading] through EPADS before the last date and time for submission of bid.
4. The contractor / firm / constructor must upload all mandatory documents like PDA / Provincial Enlistment / renewal, valid PEC Registration, NTN (Active), KPRA (Active), Affidavit of never been blacklisting / litigation status by the Government / Semi-Government or any Autonomous body, etc. on EPADS as per the required criteria.
5. The bidders shall upload a scanned copy of their bid security/additional security (if any) through E-PADs along with the Financial proposal and submit the original bid security / additional security (if any) in sealed envelope, (in the shape of bank guarantee issued by a scheduled bank in Pakistan or CDR in favor of the Director General, PDA) to the office of the undersigned through registered post / courier before last date and time for bid submission. By hand submission will not be accepted.
6. The bidders shall submit their 2% bid security and additional bid security (if any) as per KPPRA rules and KPPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10/05/2022.

7. The received technical bid(s) shall be opened (downloaded from EPADS) in the Conference room of PDA on the date and time mentioned above, in the presence of bidders or their representatives who opt to be present.
8. Technical bid(s) shall be evaluated in accordance with the criteria specified in the BSDs. Bidders shall ensure that all requirements are fully understood and that the required documents are submitted as part of their technical bids. The evaluation process shall be conducted strictly in accordance with the requirements set forth in the BSD's and the information and documents provided in the technical bids submitted by the bidders.
9. The "Financial Bids / Proposals" of only technically responsive and qualified bidders will be opened in the presence of bidders / their representative (who may like to attend) on the date & time to be notified later on. Whereas, the "Financial Bids" of technically non-responsive/dis-qualified bidders shall be returned unopened to the respective contractor / firm.
10. In case if Bids / Proposals are not opened on the above-mentioned date due to unforeseen reasons, these shall be opened on the next working date at the same place & time.
11. Bids only up to two decimal digits (0.00) will be considered for evaluation. If any document submitted along with bid documents is found false/fake/bogus, the registration of the contractor / firm shall stand cancelled / blacklisted from PDA.
12. The content of the bids, uploaded by the bidder on EPADS, shall be readable. Incomplete / disfiguring / overwriting / by hand / conditional shall be considered non-responsive.
13. Clarifications / queries, if any, shall be asked / communicated through EPADS or from the office of the undersigned within the office hours before last date and time for submission of bid.
14. All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
15. Submission of the bid by the contractor / firm implies that they are fully conversant with the site, scope of work and terms and conditions laid down in the tender / bid document.
16. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025 / prevailing market rates for NSI with the approval of the competent authority.
17. If the Bid becomes tie, it will be decided through open toss.
18. The procuring entity may reject all bids at any time prior to the acceptance of a bid. The procuring entity shall upon request communicate to any contractor who submitted a bid, the grounds for rejection of all bids as per KPPRA Rule 47.
19. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
