The interested and eligible bidders/contractors duly registered on EPAD link <https://kp.eprocure.gov.pk> /supplier/registration are eligible to apply under Single stage two-envelope method of KPPRA Rules. The E-bid must be submitted/uploaded through EPADS on or before 23-07-2026 at 12:00 PM. The technical bids on EPADS (e-bidding) shall be opened on the same day at 02:00 PM as per KPPRA rule.
3. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted/ responsive bids shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through E-PADS and the provided email address.
4. ORIGINAL two (2%) bid security of the total bid price in the shape of CDR in the name of "TMO TMA HAVELIAN" shall be sealed in envelope and marked as such and shall reach on below given address before the closing date and time.
5. All applicable taxes including Sales tax, Income tax, KPPRA taxes, and stamp duties etc. as per Government Rules enforced shall be applicable.
6. All the rates shall be quoted on (FOR) basis with free supply/delivery from and to the TMA office.
