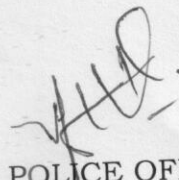

2. Interested bidders must submit their Bid via E-PADS (Scan Copy) and original Bid (Hard copy) submitted in sealed envelopes marked as "Technical Bids" which must reach the office of the undersigned through register courier service before closing time and date mentioned above.
3. The bidders who are failing to submit their bids through both (**soft and hard**) shall be declared non-responsive and their bids shall not be considered for evaluation. Technical evaluation will be carried out in the office of Chairman Procurement Committee on the basis technical evaluation criteria given in bid solicitation document.
4. Bids received through hand/fax/telephone/email would not be entertained.
5. Any electronic bidders who submit fake or forged documents or information shall stand De-Barred.
6. In case of material deviation or change between the hard and soft copies of the bid, the bid shall be deemed rejected and non-responsive.

In case of any unforeseen reasons, public holidays, unrest or force majeure on the bid submission /opening date, the bid shall be opened on next working day at the same place and time.
