The E-bid must be submitted/uploaded through EPADS on or before **09-07-2026 12:00 PM**. The Technical Bids on EPADS (E-Bidding) shall be opened on the same day.
2. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted / responsive bids shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through the provided email address.
3. ORIGINAL Two percent (2%) bid security of the total bid price in the shape of CDR in the name of "TMO TMA Takht-e-Nasrati" in sealed envelope shall reach the office of the TMO, TMA Takht-e-

4. Specifications / Details will be uploaded on EPADS to download.
5. All applicable taxes including Sales tax, Income tax, KPPRA taxes, and stamp duties etc. as per Government Rules enforced shall be applicable. The manufactures/suppliers should provide FBR registration/Tax Payer certification for supply of components. Letter of authorization (duly approved by the competent authority) may also be provided with documentations failing which the bid will be considered non-responsive.
6. All the rates shall be quoted on (FOR) basis with free supply / delivery to the TMA office.
7. Successful bidder shall provide complete operational training to the staff.
8. Incomplete, conditional, late submission or by hand bids shall not be entertained / accepted.
9. Purchase Order will be issued subject to release of funds.
10. The competent authority reserves the right to accept or reject any or all tenders with cogent reason as per KPPRA Rules.
