TERMS & CONDITIONS:

1. PROPOSAL SHOULD ACCOMPANY THE FOLLOWING:

- Fresh LCB Registration for CFY.
- CNIC Photocopy & Fresh Registration of KPRA & FBR.
- Valid Pakistan Engineering Council Registration Copy for CFY.
- Form H of the Company / Firm if any.
- Documents Showing general capabilities, financial soundness, general and relevant experience record, personnel capabilities, equipment capabilities and Income Tax / NTN Certificate etc.
- The bid security shall be kept sealed in financial proposal. The bidder shall additionally place an affidavit in the technical proposal stating that a bid security amounting to 2 percent without indicating figure in the letter has been placed in financial proposal or bid. Otherwise, the technical proposal will be considered as non-responsive and will be returned to the bidder after being examined by procurement entity.
- Annual Audit Report of Last five years duly verified by Recognized Audit Firm.
- For Serial No. 02, 03 & 04 firm must attach relevant experience of last five years (Similar nature Work).
- Any other documents to support the technical bid.

2. For Serial No. 02, 03 & 04 Firms must have following Codes of Electrical i.e of PEC i.e CE01, CE04, CE09 & CE10 EE01, EE02, EE03, EE04, EE06, EE10, EE11 (EE11(i) (Solar), EE11 (vi) (General Electrical Works), ME-06, ME-07, BC01, BC02.
3. Firm must have Electrical inspectorate License/Certificate Category A for Serial No. 02, 03 & 04 issue by the Government Electrical Department Khyber Pakhtunkhwa.
4. Securities and Exchange Commission of Pakistan (SECP) Registration: Where the bidder is an incorporated company, it shall submit a valid Certificate of Incorporation and the latest Company Registration Certificate issued by the Securities and Exchange Commission of Pakistan (SECP) under the provisions of the Companies Act, 2017, along with the Technical Proposal. The Procuring Entity reserves the right to verify the authenticity and current status of the company through the official records of SECP. Failure to furnish the required documentary evidence, or submission of an invalid, expired, suspended, or fake certificate, shall render the bid liable to rejection in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Act, Rules, and the bidding documents.
5. A complete set of Bid Solicitation Documents can be download from the official website of EPADS and can also be obtained from the office of Tehsil Officer (I&S) Tehsil Municipal Administration, Takht Bhai. In case of any further information / clarification, the bidders may visit the office on any working day before the closing of the bid or contact on Phone No.0937-551016 or 552806.
6. The interested bidder shall physically submit their original proposal / bids according to the information required in the SBD, in the office of undersigned, via courier / registered post, before last date and time for submission of bid (by-hand submission of is not allowed).
7. The bid shall also be submitted (electronically) through EPADS (uploading of soft copy of submitted proposals/bids) before last date and time for submission of bid, otherwise, the bidder shall be considered as non-responsive.
8. There shall be no variation between the original and copy of proposal / bids. In-case of variation the bid shall be considered as no-responsive.
9. The bidder shall submit / quote their bids as per KP-PPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10-05-2022.
10. Clarification / queries, if any shall be asked / communicated through EPADS.
11. The bid securities shall be in the shape of call deposit receipt in favor of the Tehsil Municipal Officer, Tehsil Municipal Administration, Takht Bhai.
12. The bidders are required to quote their rates above or below on both MRS as well as on Non MRS items.
13. Any bidder who provides false, or materially inaccurate or incomplete will be disqualified as per KPPRA rules.
14. Any Bidder who provides fake or forged documents or information shall stand De-Barred.
15. In case of Tie/Draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
16. The bidder on a written request to procuring entity can withdraw their bids till closing time of the bid.
