

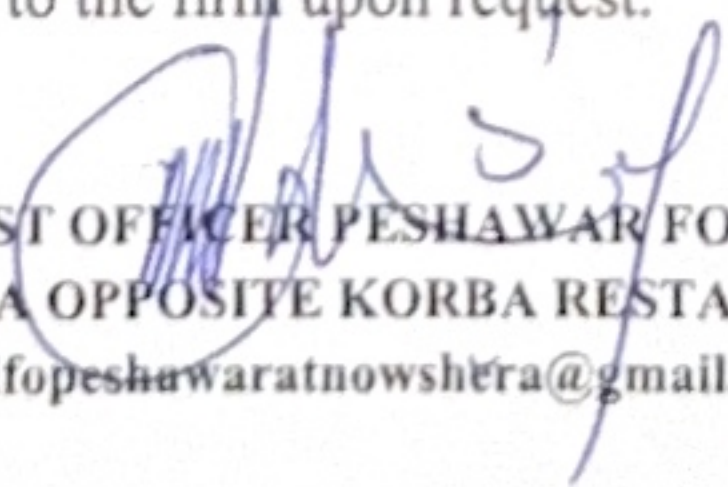

- For Package one (I& II) Eligible bidders having valid Nursery Registration with Federal Seed Certification and Registration Department (FSCR Department) and registered with Pakistan Engineering Council in relevant category C-6 with relevant codes CE-10 (v) Horticulture) may participate in the tender process. The Bidder shall possess experience of successfully executing similar nature plant supply contracts for Government, Autonomous/Semi-Autonomous Bodies, and National or International Organizations during the last three (03) years, duly supported by copies of work orders and/or completion certificates. For Package three (03) general order supplier may apply.
- Eligible bidders may download complete Bid Soliciting Documents from EPADS.
- ORIGINAL two (2%) CDR of the total bid price in the name of "Divisional Forest Officer Peshawar Forest Division Nowshera" in sealed envelope marked as such shall reach on below given address before the closing date and time.
- Bid must be signed and stamped by the authorized person of the firm before uploading a scan copy on EPADS.
- All federal and provincial duties/stamp duty/taxes including KPRA taxes will be recoverable as per directives of the government issued from time to time.
