Terms & Conditions for E-Bidding:-

1. All bidders are requested to upload their Bids (CDR's & Rate on BOQ / BID Documents along-with relevant documents in one PDF file) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the prescribed closing date and time. Any bid received without uploading required documents i.e (copy of CNIC, Enlistment with Govt. of KP, Pakistan Engineering Council, Active KPPRA status & Active FBR status and rate analysis if required) and incomplete/conditional bids with unattested cutting /overwriting/disfiguring uploaded shall be considered as NON-RESPONSIVE. No hard form / print out of bid are required / acceptable except CDR/call deposit. The Procuring Entity shall not be responsible for any technical fault, glitch, or error in the EPAD system and shall only consider the documents appearing on the EPAD dashboard. Therefore, all bidders are advised to upload the required documents carefully and responsibly.
2. Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
3. The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol:1-24/2021-22/6058-71, dated: 10-05-2022 & notification No.S.R.O (29)/Vol:1-40/2025-26/699-711 dated 29.10.2025.

4. Bid Security @ Rs.2% (or additional security if required) of the Engineer's estimated shall be submitted in the shape of call deposit (original) from the schedule Bank in the favour of Executive Engineer Swabi Irrigation Division-1 Swabi. The CDR shall be submitted in a sealed envelope before the bid opening time.
5. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
6. The bids will be valid for one hundred & twenty days (120) from the date of bids opening.
7. In case of same rates quoted by the contractors, the lowest bidder shall be decided through draw as per para-viii of notification vide Chief Engineer (North) Irrigation Deptt: No.4074/C-1/KPPRA dated 11.12.2025.
8. Additional Security where applicable shall be furnished by the successful bidders in accordance with KPPRA rules 2014 (as amended and relevant Govt: notification).
9. Any Bidder who provides incorrect information shall be liable to dealt with under section 29 of the KPPRA Act read with rule 44 of 2014.
10. All the bidders are requested to download the bidding documents from the KPPRA website/ Irrigation Department Website: www.irrigation.gkp.pk or EPADS: <https://kp.epprocure.gov.pk/>.
11. Pre-bid meeting will be held on 23/07/2026 in the office of the undersigned at 11.00 Noon.
12. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
13. Mandatory conditions as per solicitation bidding documents (SBDs) will be adhered.
14. The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
