

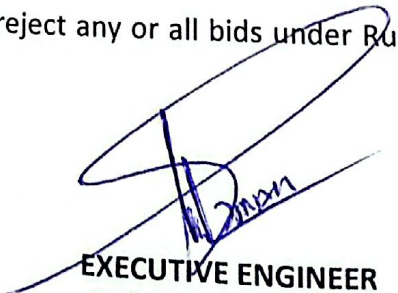
NOTICE INVITING TENDER THROUGH E-PADS

PHE Division Hangu, Government of Khyber Pakhtunkhwa invites electronic bids through **EPADS** system from government contractors/firms registered with PEC, KPRA, FBR, and enlisted with the KP Central Enlistment Committee for the following work:

TERMS & CONDITIONS:

1. Bidding shall be carried out through **EPADS** as per KP-PPRA Rules (as amended) under Single Stage Single Envelope procedure.
2. The bid must be accompanied by a Call Deposit Receipt (CDR) equal to 2% issued by schedule bank of the estimated cost.
3. The bidders must submit additional bid security in case he quotes rates more than 10% below the engineer's estimate, in accordance with rule 20(2) of the KP-PPRA Rules 2014 (as amended).
4. All Bidders/Contractors must have registration with Khyber Pakhtunkhwa Revenue Authority (KPPRA) & PEC with Active Status and having codes i.e **CE-09 for Civil Work and EE-04, EE-05, EE-11, and ME-07** for repair of Electric Machinery and Solar works, otherwise his bid will be considered non-responsive.
5. The following attested documents must be attached with the bid:
 - i. CNIC
 - ii. Valid PEC Registration
 - iii. KPRA & FBR Registration
 - iv. KP Central Enlistment Certificate
 - v. Form-H/SECP (if applicable)
 - vi. KP Electric Inspectorate Registration (only for electrical & mechanical works)
 - vii. Electrical & Mechanical Workshop (only for electrical & mechanical works)
 - viii. Power of Attorney (if applicable)
6. Incomplete or conditional bids shall be rejected.
7. Bidding documents/BOQ must reach to the office of **XEN PHE Division Hangu** through registered courier on or before **11/08/2026 upto 1200 Hours** which will be opened on the same date at **12:30 Hours**.
8. The competent authority reserves the right to accept or reject any or all bids under Rule 47 of KPPRA Rules.
