The Medical Superintendent District Headquarters (DHQ) Hospital Nowshera invites sealed/online e-bids from EPADS registered firms (FBR/EPADS/KPRA) via **SINGLE STAGE ONE ENVELOPE** bidding procedure as per rule 6(2)(a) KPPRA rules 2014, for FY 2026-2027 for following categories:

### TERMS AND CONDITIONS

- Bidding process will be carried out exclusively on E-Pak Acquisition and Disposal System (EPADS) KP-PPRA Portal: <https://portalkp.eprocure.gov.pk/#/>
- Bidding Documents (BSDs) can be downloaded by the EPADS-registered firms online from Active Tenders Lists available on EPADS account of District Headquarter Hospital (DHQ) Nowshera.
- Bidders must carefully read and comply with Mandatory Documents Checklist mentioned in the respective bidding documents. Offers will be rejected if required mandatory documents are not uploaded as single PDF file on EPADS, submitted late, unsigned, without original CDR, ambiguous offered rates/documents, or from blacklisted firms by Health Department KP, KPPRA, or any government (Federal or Provincial). Such bids will be considered non-responsive and excluded from evaluation/bidding process.
- Bidders must be on FBR/Active Tax Payer list and shall be registered with all authorities/ departments where applicable. All related documents/certificates shall be attached in bids.
- Quotation must be clearly scanned, computer typed & printed; and the offered rate must be written both in words & in figures on the official letterhead of the Firm/bidder, duly signed and stamped.
- Bidders must give their best and final unit prices and highest possible discount on Maximum Retail Price (MRP) for the quoted items because no negotiations on quoted rates are allowed under the KPPRA rules, 2014. All the taxes will be deducted as per the rules.
- Rates shall be valid till **30<sup>th</sup> June 2027** per KPPRA rule 31(A) Framework Contract (extendable).
- Bidders must submit original CDRs to this hospital in sealed envelope and upload all mandatory documents as a single PDF file on EPADS website <https://portalkp.eprocure.gov.pk/#/> before bids closing date/time.
- Bids must be submitted on EPADS and CDRs must be submitted in sealed envelope to the Medical Superintendent Office before **10:00 AM on 30/07/2026** (bid closing). No tender will be accepted after due date/time.
- Bids will be opened on EPADS in the presence of the bidders or their authorized representative(s) at **10:30 AM on 30/07/2026** (bid opening) by the Procurement Committee. *Note: In case of Public Holiday or any emergency, next working day will be tender opening day (keep in contact with Administration).*
- The Competent Authority has the right to accept or reject any bid as per KPPRA Rules 47 (1)
