Executive Engineer Building Division District Mohmand At Ghallanai Government of Khyber Pakhtunkhwa invites Electronic Bids on EPAD system from the eligible firms / Bidders, in accordance with Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) Rules -2014 on Single Stage Two Envelope procedure, amended up-to vide Notification No. SOR (14) Vol: 1-24/2021-22 dt: 10-05-2022, The Firm/Contractor must be register with Pakistan Engineering Council (PEC) for the CFY 2026-27 through EPADS for the following works:

Terms & Conditions.

1. Bidding Solicitation Documents along-with Bidding Criteria and instruction to bidders can be downloaded from the official EPADS website and C&W website (www.cwd.gkp.pk) as well as KPPRA website (www.kppra.go.pk) before the submission time. Bids submitted without requisite documents or incomplete will not be processed further for Technical Evaluation.
2. Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the Technical Proposal, affirming that the CDR enclosed in the sealed financial bid is authentic and original. In case of non-availability of the affidavit, the firm/bidder shall be considered as non-responsive.
3. Original Copies of Call Deposit Receipts (CDRs) for Bid Security (from Scheduled Banks), Stamp Duty is mandatory as well as Bid Entry Fee (Non-Refundable for each Bid @0.03% of the Estimated Cost Without fail; to be enclosed along with the Technical proposal and shall reach to the office before closing date/time.
4. A copy of the Technical proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS System.
5. Electronic bidding will be done on "Above/Below" system on BOQ Engineer's Estimate, based on MRS applicable.
6. Bid Security of 1st, 2nd & 3rd, lowest bidder will be retained by the Procuring Entity till approval of the bid.
7. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
8. The competent Authority reserves the right to reject any or all the tenders by assigning the cogent reason(s).
9. Bid will be valid for (90) days.
10. Details of similar nature and other general works, in hand and completed during last Three years supported by work orders and completion certificates duly attested form Executing Agencies concerned.
11. Machinery (Tools, Plants & Equipment etc.) supported with the purchase documents as evidence of ownership.
12. Particular of Technical Staff Engineers along with updated CVs and their agreement (for the current year) on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given along with their registration number of PEC and contact numbers.
13. Financial soundness supported by annual Audit reports for the previous year (2025-26).
14. Tax returned certificate for the previous year (2025-26).
15. All other terms conditions including KPPRA amended Rules can be seen on official website of the C&W Department or from the office of the undersigned on any working day during duty hours.
16. All Federal / Provincial duties / Stamp duties / Taxes will be recovered as per direction of the Government issued from time to time.

17. The contractor quoting their bids up to a limit of 10% below Engineer Estimate Shall be submit bid Security @ 2% only of Engineer Estimate.
18. The Contractor quoting their bid more than 10% below up to 20% below on Engineer Estimate shall submit along with their bids 8% additional Security in Shape of Call Deposit/Bank Guarantee on Engineers Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered is Non responsive & the 2% bid security shall be forfeited in favour of Govt: and the second lowest bidder and so on will be considered accordingly.
19. (Similarly , a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the Differential amount of submitted bid and Engineer Estimate along with detailed rate of analysis) In case of more than 20% below bids, If the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then, the said bid shall be considered is non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Govt: and the seconded lowest bidder and so on will be considered accordingly.
20. Separate Brochure / Technical Proposals for each work along-with required documents shall be submitted clearly mentioning the Scheme Name and No.
21. The Participation contractors (s) must submit their updated FBR (Active Status), KPRA (Active Status), PEC License and C&W Enlistment copies for the current financial year, for the work on the day of opening of tender (s).
22. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under Finance Act, 2013 Act No. XXI of 2013.
23. The Financial Bid will be opened after the approval of Technical Evaluation from the Competent Authority.
24. Period of Completion will be based on Work Order.
25. Any condition / Instructions, if missing will be dealt in light of KPPRA rules.
26. The undersigned has the right to reject the Bid of those Contractors whose past performance is not satisfactory with this Division shall be considered non-responsive.
27. A Complete set of Criteria / Bid Documents should be Obtained (separately for each Bid) by an interested eligible bidder on submission of written application from the office of undersigned on any working days before closing date on 07-08-2026 i.e. payment of Rs:5000/- (non-refundable) otherwise his bid will not be entertained.
28. Pre-Bid meeting will be held on 07-08-2026 (Friday) in the office of C&W Building Division Mohmand at Ghallanai at 11:00 AM.
29. Venue of bids opening is office of the Executive Engineer C&W Building Division Mohmand At Ghallanai.
