**PRE-QUALIFICATION NOTICE
Outsourcing of Sports Facilities**

The Directorate General of Sports, Government of Khyber Pakhtunkhwa intends to outsource the management operations and maintenances of sports facilities at Hayatabad Sports Complex and Peshawar Sports Complex to private sector parties.

In this regard, the Directorate General of Sports invites applications, through the **E-Pak Acquisition and Disposal System (EPADS)**, from experienced, reputable, and financially sound individuals (who can demonstrate an active long-term interest in the respective sports), firms, clubs, and companies for pre-qualification for the outsourcing of sports facilities at Peshawar Sports Complex and Hayatabad Sports Complex.

Scope of Services:

The scope includes operation, management, maintenance and allied services of hockey grounds, gymnasium, squash courts, tennis courts, swimming pool, Badminton hall, Basketball hall and volleyball court. The successful Bidders shall ensure that all facilities are properly maintained, facilitate players, clubs and the general public, and actively promote sports activities and events.

The facilities will be handed over on an "AS IS WHERE IS BASIS" for a period of 05 years, extendable for another 05 years on satisfactory performance.

Eligibility Criteria:

Interested firms must possess relevant experience, financial capability, valid registration with tax/regulatory authorities, and must not be blacklisted by any government or semi-government organization.

General Instructions:

Pre-qualification will be carried out in accordance with KPPRA Rules. Only pre-qualified firms/individuals will be invited to participate in the subsequent bidding process.

A Pre-Bid Meeting for the Pre-Qualification process will be held on **04th August 2026 (Tuesday) at 02:00 PM** in the Committee Room, Directorate General of Sports, Khyber Pakhtunkhwa, to clarify the Pre-Qualification Documents and respond to queries of prospective applicants.

Applications shall be submitted via EPADS (<https://portalkp.eprocure.gov.pk/#/tenders/Epadtenders>) on or before **10th August 2026 at 1:30 PM**. Applications will be opened electronically on the same day at **2:00 PM** in the Committee Room of the Directorate General of Sports, Khyber Pakhtunkhwa, in the presence of the applicants or their authorized representatives who wish to attend.
