- 1- Bid Solicitation/Bidding Documents can be downloaded from the EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website (www.kppra.gov.pk) .
- 2- The eligible contractors/Firms are required to submit their **Technical and Financial Bids** through EPADS. **Financial proposals / bids** will be sent to the **Office of Assistant Director, Bannu** through registered courier service before bid submission due date & time.
- 3- The last date and time of submission of electronic Tender form is 06th August, 2026 at 12:00 PM. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
- 4- Last date and time for online clarification is 31st July, 2026 at 05:00 PM.
- 5- Technical Proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
- 6- Cutting /overwriting in the in bid solicitation documents will not be acceptable.
- 7- The "Technical Bid/ Proposals" of the firms /contractors will be evaluated based on criteria mention in the bidding solicitation documents.
- 8- The "**Financial Bid/Proposals**" of only technically responsive qualified bidders will be opened after evaluation of technical bids in the presence of bidders /their representative (who like to attend) whereas the "Financial Bids" of the technically non responsive bidders shall be returned unopened to the respective contractors.
- 9- The securities shall be in shape of call deposit in favor of the **Assistant Director (Senior) LG&RDD H.Q Bannu.**

- 10- Matters related to Bid Security and additional Security shall be dealt in accordance with KPPRA Notification No. S.R.O(29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional Bid security shall be in accordance with Notification No.S.R.O.(14)/Vol: 1-24/2021-22 dated 10th may,2022.
- 11- The call deposit i.e. bid security for the work/ contract must be prepared after publishing of the NIT and before the closing time of the bid.
