NOTICE INVITING E-TENDER

(Under KPPRA Rules for E-PADS Online Tendering Process)

The Tehsil Municipal Administration (TMA) Lakki Marwat invites electronic bids (E-bids) through the E-Pak Acquisition and Disposal System (E-PADS) on a Single Stage Two Envelope procedure. Bids are invited from eligible Bidders registered with the Pakistan Engineering Council (PEC) in the relevant category, enlisted with the Local Council Board (LCB) Khyber Pakhtunkhwa, and registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) for the financial year 2026-27.

The sub-schemes are approved under the ADP scheme "240245 – Solarization of Tubewells in Khyber Pakhtunkhwa" as per administrative approval letter No. PO (LG) / 1-6 / PDWP / AA / 2025-26 dated 04-05-2026:

TERMS & CONDITIONS:

- 1. Submission Method (E-PADS Only):** All bids must be prepared and submitted electronically via the official Khyber Pakhtunkhwa E-PADS portal (<https://kp.eprocure.gov.pk>). Manual, physical, or offline bidding without system registration and online submission is strictly prohibited and will be rejected instantly.

2. Bid Solicitation Documents (BSD) / Bidding or Contract Data / Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA (kppra.gov.pk).

3. **Key Timelines:** The bid submission deadline is up to 11:00 AM on 26 August 2026. Bids will be opened online on the same day at 11:30 AM in the presence of participating contractors or their authorized agents in the committee room of TMA Lakki Marwat.

4. **Mandatory Registration:** Bidders must possess active registration with (i) Pakistan Engineering Council (PEC) for financial year 2026-27 with codes EE-11 (Solar Energy) and ME-07 (Water Supply); (ii) Local Council Board (LCB) Khyber Pakhtunkhwa; (iii) Khyber Pakhtunkhwa Revenue Authority (KPRA); and (iv) Federal Board of Revenue (FBR) Active Taxpayer List (ATL).

5. **Bid Security Structure:** A 2% normal bid security of the estimated cost in the form of a Call Deposit Receipt (CDR) from a scheduled bank in the name of the 'Tehsil Municipal Officer, TMA Lakki Marwat' must be prepared before bid submission.

6. **KPPRA Rules on Additional Security (SRO-14):**

- Contractors quoting bids up to 10% below the engineer's estimate shall submit 2% bid security only.
- Contractors quoting bids more than 10% below and up to 20% below shall submit 8% Additional Security of the Engineer's Estimate along with the bid.
- Contractors quoting bids more than 20% below shall submit additional security equal to the differential amount along with a detailed rate analysis in accordance with KPPRA SRO instructions.
- Failure to submit required additional security will render the bid non-responsive, and the normal bid security will be forfeited.

7. **Hard Copy Submissions:** The physical original CDR of Bid Security must reach the Office of the Tehsil Municipal Officer, TMA Lakki Marwat, before the deadline of bid submission.

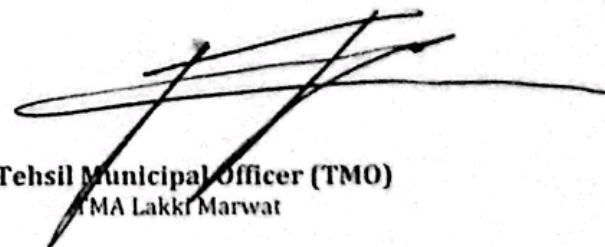
8. **Rates and Cost Structure:** Tender rates must be quoted online through the E-PADS platform based on the 'Above / Below' percentage on the relevant Market Rate System (MRS) and non-MRS items.

9. **Issuance of Work Orders:** Standard execution contracts and work orders will be issued to the lowest responsive evaluated bidder, contingent on the formal release of funds.

10. **Right of Rejection:** In accordance with KPPRA Rules, the competent authority reserves the right to reject any or all bids, or any tender process, by providing justifiable, cogent reasons prior to acceptance.
