2. Bidders are advised to inspect scrap at the location / address mentioned above prior of auction date and time and bidders are informed to bring copy of CNIC and CDR at the time of registration to WSSP.

The highest ranked bidder will be required to deposit one-fourth (1/4th) of the bid amount with WSSP on the same day in shape of Demand draft, CDR or Cash deposit directedly in **WSSP BoK Bank Account#: 3000823995**, otherwise his bid shall be considered as cancelled and security amount shall stand forfeited in favor of WSSP.
4. The highest bidder will have to deposit the remaining bid amount within 7 days of approval of bid, otherwise the deposited (1/4th) and security amount shall stand forfeited.
5. Base price inclusive of all government applicable taxes to be announced at the time of auction.
6. The successful bidder will be required to collect auctioned scrap material only, immediately after award of contract and if the site is not cleared by the successful bidder within 10-15 working days, penalty may be imposed.
