NOTICE INVITING E-BIDDING

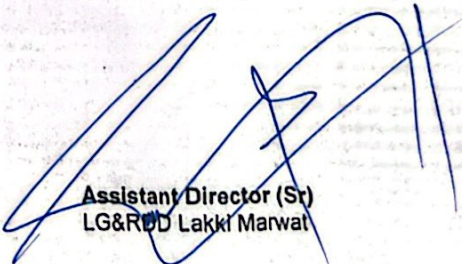
Sealed e-bids based on MRS-2025 (1st Biannual) and approved Non-MRS Items are hereby invited under the Single Stage – Two Envelope bidding procedure from contractors/firms registered with the Pakistan Engineering Council (PEC) and enlisted with the C&W Department in accordance with the Government of Khyber Pakhtunkhwa Centralized Enlistment Policy for the Financial Year 2026–27 for the following work:

Terms & Conditions

1. The Bidding Documents may be downloaded from the EPADS Portal (www.eprocure.gov.pk) and the KP-PPRA website (www.kppra.gov.pk).
2. Eligible bidders shall submit their bids electronically through EPADS. Where required under the bidding documents, the Technical Proposal and Financial Proposal shall be submitted in separate sealed envelopes, clearly marked accordingly, and placed in one outer sealed envelope addressed to the Assistant Director, LG&RDD, Lakki Marwat, before the bid submission deadline.
3. The deadline for submission of electronic bids is 13th August, 2026 at 12:30 PM. The date and time for opening of Financial Bids of technically qualified bidders shall be communicated separately after evaluation of the Technical Proposals.
4. The last date and time for seeking online clarification is 05th August, 2026 at 05:00 PM.
5. The Technical Proposal shall be properly page-numbered and shall include a table of contents corresponding to the numbered pages.
6. Cutting or overwriting in the bid documents shall not be acceptable. Any discrepancy between the documents uploaded on EPADS and the hard copies submitted shall render the bid non-responsive and may lead to disqualification.
7. Technical Proposals shall be evaluated in accordance with the evaluation criteria specified in the Bidding Documents.
8. Financial Bids of only technically responsive and qualified bidders shall be opened in the presence of the bidders or their authorized representatives who choose to attend.
9. Bid Security shall be submitted in the form of a Call Deposit Receipt (CDR) in favour of the Assistant Director, LG&RDD, Lakki Marwat.
10. Matters relating to Bid Security and Additional Security shall be governed by the applicable KP Public Procurement Rules and notifications.
11. The Call Deposit Receipt (CDR) for Bid Security shall be issued after publication of this NIT and before the bid submission deadline.
12. In case of a tie among the lowest evaluated responsive bidders, the matter shall be decided in accordance with the applicable KP Public Procurement Rules.
13. Bids shall remain valid for 180 days from the bid submission deadline.
14. Contractors intending to participate in the bidding process must be registered on EPADS and possess a valid user account.
