Terms and Conditions:

1. Bid Solicitation Documents (BSD) which includes Bidding or Contract Data, Bill of Quantity (BOQ), & Criteria for Basic Eligibility, Technical Bid Evaluation, & Financial Bid Evaluation, can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before last date and time for submission of bid.
3. The bidder shall submit, physically, their work-wise original bid security(ies)/additional security(ies) (in the shape of call deposit receipt (CDR) made in favour of the undersigned) in the office of the undersigned through registered post/courier before last date and time for bid submission.
4. The bidder shall also submit, in a separate sealed envelope, work-wise (individually) non-refundable bidding document fees i.e., Rs. 2,000 in the shape of call deposit receipt made in favour of the undersigned through registered post/courier before last date and time for bid submission. This sealed envelope shall be opened at the time of Technical Bid Opening. In case of bidder(s) fails to submit the said non-fundable fee, their bid(s) shall be considered as ‘non-responsive or technically unqualified’.
5. The received technical bid(s) shall be opened (downloaded from EPADS) in the presence of bidders or their representatives who opt to be present.
6. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
7. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive.
8. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.
9. The bidders shall submit their bids as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
10. KP-PPRA’s Notification No. S.R.O.(29)/Vol:1-40/2025-26/699-711 dated 29/10/2025 shall be applicable.
11. If any clarification/query is sought by any bidder, the bidder may communicate through EPADS.
12. The detail and scope of the project is mentioned in the BSD.
13. The bidder shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) with active status.
14. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
