The Medical Superintendent, Muhammad Ayaz Shaheed Memorial Hospital Category -C/ THQ Hospital, Takht Bhai, Mardan invites eligible, reputable and duly registered firms/individuals to apply through the e-PADS (e-Pak Acquisition and Disposal System) (e-PADS portal (<https://eprocure.gov.pk>)) for the following eight (08) separate procurement/lease packages for Financial Year 2026-2027. Packages 1-5 & 8 (goods/services) shall be procured under Single Stage – Single Envelope procedure as per Rule 6(2)(a) of the KPPRA Rules, 2014; Packages 6 & 7 (Car Parking & Canteen – lease/license of hospital premises) shall be processed as open competitive bidding for lease/disposal of public assets under Rules 50C & 50D of the KPPRA Rules, 2014:

ELIGIBILITY CRITERIA

Bidders must be on FBR Active Taxpayer List (ATL); hold valid NTN/STRN/GST registration; hold a valid Drug Sale License (for Packages 1 & 2); be registered on e-PADS/KPPRA portal; and must NOT be blacklisted/debarred by any Government department. For Car Parking & Canteen contracts (Packages 6 & 7), bidders must additionally hold relevant trade/business registration, NTN, and registration with the Khyber Pakhtunkhwa Revenue Authority (KPPRA) as applicable under Rule 37A of the KPPRA Rules, 2014.

BID SECURITY

Mandatory Bid Security in the form of a Call Deposit Receipt (CDR) issued by a scheduled bank, in favour of the **Medical Superintendent, Muhammad Ayaz Shaheed Memorial Hospital / THQ Hospital, Takht Bhai**, shall be submitted with each bid (amounts as per table above). Pay Orders and cheques will NOT be accepted. [Rule 12, KPPRA Rules 2014]
