E-bids are invited under Single Stage Single Envelop Method from Government registered workshops /Firms / Authorized Dealers/Company for the “**Installation of Front-End Bucket in Messi Tractor-2 of (Zone-B) WSSP**”.

Terms & Conditions.

1. Interested and eligible bidders / Authorized dealers will be required to register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration>.
2. Bids must be submitted on EPADS on or before **August 13, 2026, till 11:00 am**. The bids of participating bidders submitted on EPADS (only) will be accepted and opened publicly on same day at 11:30 am.
3. ORIGINAL two (2%) CDR of the total bid price in the name of “**WSSP Contractor Securities**” in sealed envelope marked as such shall reach on below given address before the closing date and time.
4. The interested bidders should deposit a fee of PKR 2000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase 3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers. The deposit slip fee amounting to Rs. 2000/- must be submitted before the closing date and time along with CDR.
5. The Messi Tractor-2 of (Zone-B) WSSP can be inspected at WSSP Zone -B parking Yard, for the purpose of inspection contract (Mr. Mustarif Khan: 0333-9293883).
6. Subcontracting/subletting of works is not allowed. If the bidder is found to be involved in subcontracting after the award of the Contract (wholly or partially). The contract awarded will be cancelled immediately. The bid security will be forfeited, and the bidder will be recommended for blacklisting/debarment.
7. The bid must be stamped and signed by an authorized person of the firm before uploading on EPADS. All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with Income Tax and KPRA. (Rule: 37A of KPPRA Rule 2014).
