- 1) Bid Solicitation/ Bidding Documents can be downloaded from the EPADS website i.e (www.kp.eprocure.gov.pk).
- 2) The eligible contractors/ firms are required to submit their Bids through EPADS as well as also send their bid in hard and sealed envelopes i.e one envelope containing "Technical Proposal" and clearly marked as "Technical Bid" accompanied, while the second envelope containing financial bids clearly marked as "Financial Bid". Both Technical and Financial proposals/ bids will be placed in a single sealed envelope and addressed and sent to the Office of the Tehsil Municipal Officer, TMA Badhber, Main Kohat Road, near Ring Road Flyover, Garhi Qamar Din, Peshawar through registered courier service before bid submission due time.
- 3) The securities shall be in shape of call deposit in favor of Tehsil Municipal Officer, TMA Badhber Peshawar.
- 4) The last date and time of submission of electronic tender form is 17-08-2026 at 12:30 PM. The date and time of Opening of Financial Bid shall be announced after evaluation of Technical Bids.
- 5) Technical Proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of proposal according to the numbered pages.
- 6) Any disfiguring/ overwriting, manipulation in the tenders shall be liable to rejection.
- 7) The "Technical Proposals/ Bids" of the firms/ contractors will be evaluated based on criteria mention in the bidding Documents.
- 8) The scope of the work can be increased or decreased as per site requirements, non-BOQ items if any, will be paid as per MRS 2025 (1st Bi Annual)/ MRS based analysis if non-scheduled.
- 9) The "Financial Bids/ Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence bidders/ their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
