5. Interested bidders shall submit bid by uploading scan copy of bid on EPADS on or before **date & time as mentioned above**. The bidders shall upload all relevant/mandatory document on EPADS.

The Bid Security Original in shape of CDR or bank guarantee (in Hard form) for Rs.320,000 and Tender processing fee Rs.2,000 in shape of CDR (Hard copy) or online deposit slip must be submitted to the office of the Procurement Officer, Women University, Swabi on or before **date & time as mentioned above**. If the original Bid Security does not reach the aforementioned office by the closing date & Time, the bid will be rejected.
7. Income Tax, KPRA or any other Government taxes will be charged as per rules.
8. All bidding process shall be carried out as per Act and Rules of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA).
9. Bids received by hand/Post/Courier; E-mail / Fax shall NOT be accepted.
