TENDER NOTICE (e-PADS)

Office of the COMMANDANT SPECIAL SECURITY UNIT SSU, Khyber Pakhtunkhwa invite sealed tenders on Two Stage Two Envelopes based on the Khyber Pakhtunkhwa for Public Procurement of Goods, Works & Service Rules 2014 from bids under National/ Competitive Bidding from manufacturers, or from their authorized distributors for Financial Year 2026-27 for the procurement of repair of transport (Govt: Vehicles repair spare part, tyre & tube, complete engine and battery etc) for Special Security Unit SSU and associated all projects Balakot Hydro Power Project BHPP District Mansehra, Remodeling of Warsak Canal System District Khyber etc. Last date for submission of proposal is 13/08/2026 upto 10:00 hrs:. Proposal will be opened on the same date at 11:00 hrs: in the presence of Procurement Committee and bidders or their representative who choose to attend in office of the Deputy Commandant SSU. The delivery period will be 15-days or as per contract agreement.

The specifications/Tender documents & NIT pertaining to the above-mentioned item can be obtained from the office of the Account Section SSU, 3rd floor elite building Malak Saad Shaheed Police Line Peshawar, at a cost of Rs 2000/- (Non-Refundable). Bidder shall submit their proposal through e-PADS and hard form in original as well, to the Account Section SSU.

Terms and Conditions:

The following terms and conditions shall apply: -

- i. Only registered suppliers, who are on Active Taxpayers list (ATL) of FBR, are eligible to supply goods/services to Government departments (where applicable).
- ii. Each firm shall submit a sample at the time of opening of technical proposals if required.
- iii. Each bid shall comprise two sealed package envelopes.
- iv. A firm that has successfully completed three to four similar/relevant tenders in previous FY year and has at least one ongoing project with police Department at the time of bidding is eligible to apply.
- v. The rate of each item with taxes be quoted and all spare parts must be genuine.
- vi. The rates quoted by the bidder for all spare parts shall be verified against prevailing market prices. If any quoted rate is found to be unreasonable or incorrect the Committee reserves the right to disqualify the bidder.
- vii. The bidders shall submit Rs. 200,000/- bid security with financial proposal from the account of the firm/bidder/contractor of any scheduled bank with their proposal in favor of the DDO SPECIAL SECURITY UNIT (CPEC) Khyber Pakhtunkhwa. In case of non-acceptance of tenders, the bid security will be refunded after finalization of the tender.
- viii. In case of acceptance of tenders, the bidders shall deposit a security Rs. 500,000/- of the total value of stores in the form of Call Deposit in the name of the undersigned and sign the contract agreement with COMMANDANT SPECIAL SECURITY UNIT SSU Khyber Pakhtunkhwa Police after completion of all codal formalities.
- ix. The Items shall be received in the office of Deputy Commandant SSU No other destination shall be acceptable if required. Items shall be physically inspected by Inspection

Committee constituted by competent authority and thereafter operationally tested at the cost of contractor. Items not found according to the standard specifications, will be rejected and may also result in forfeiture of security and black listing of the firm.

- x. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges and inclusive of packing/freight till delivery to the project site. Rates shall be valid up to 30.06.2027.
- xi. Conditional tender/application will not be entertained.
- xii. All taxes will be deducted as per existing government policy.
- xiii. The procuring entity will have the right to reject all bids or proposals at any time prior to the acceptance of bidder's proposal. The procuring entity shall upon request communicate the grounds for rejection of bid or proposal to any contractor or consultant who submitted a bid or proposal.
- xiv. The competent authority reserves the right to accept or reject any or all bids under KPPRA rules 2014.
