TERMS AND CONDITIONS

1. Tender Form / BOQ / BSDs can be downloaded after publication in the newspapers by the original registered contractors from EPADS website. (<https://portalkp.eprocure.gov.pk>), this tender will also available on KPPRA website (www.kppra.gov.pk).
2. The Tender Form / BOQ will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (Bid Submission) through EPADS.
3. Any tender or offer of works made by any enlisted contractor without filling bids online shall be null and void henceforth.
4. The bid securities shall be in the shape of call deposit receipt in favor of the procuring entity.
5. Earnest money & additional securities shall be prepared in light of KPPRA Notification No. S.R.O. (14)Vol: 1-24/2021-22 dated 10th May, 2022.
6. As per KPPRA Notification No. S.R.O (29)/Vol: 1-40/2025-26/699-711 dated 29/10/2025, bidders are required to enter detail of bid security and additional security in EPADS and the same shall be submitted to the procuring entity well before closing time and date and the same will be retained by the procuring entity until the award of contract or bid validity whichever comes first. Failure to do so action will be carried out as per the mentioned notification.
7. Bids and original call deposits received through fax or by hand will not be acceptable. Sealed bids sent through registered mail / courier service should reach up to the specified time and date as mentioned above.
8. The original envelop complete in all respect must be delivered through courier to the Office of Tehsil Municipal Administration Babuzai (Mingora).
9. The contractor or his representative can be present at time of opening of bids.
10. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before closing time of the bid apply.

11. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
12. The bidder shall have the relevant codes as per Pakistan Engineering Council against each mentioned work.
13. SECP Registration is required along with all other relevant Civil Engineering Codes.
14. The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e. Tender Form, BOQ duly signed and stamp, BSDs, Photocopy of CNIC, Enlistment & Renewal copy of Local Council Board for the year 2025-26, active NTN / Income Tax certificate, SECP Registration, valid PEC License, Active KPRA Registration.
15. The quoted rate must be clearly mentioned in words and in figures on Tender/ BOQ form. Incomplete / over-writing / dis-figuring will not be acceptable and will be considered as nonresponsive.
16. All federal and provincial duties / stamp duty / contingency charges and taxes including sales tax will be recoverable as per directives of the government issued from time to time.
17. The Department will not bound to provide any machinery/ testing laboratory and the total cost on it will be borne by the contractors themselves.
18. The procuring entity may reject all bids or proposals at any time prior to the acceptance of bids or proposals in light of KPPRA Rule-47.
19. The bidder on a written request to procuring entity can withdraw their bids till closing time of the bid.
20. No bidder shall be allowed to withdraw his bid after closing of bid time till award of the contract or till bid is valid, whichever is earlier.
21. Any bidder who provides false, or materially inaccurate or incomplete will be disqualified as per KPPRA rules.
22. Bids will remain valid for 120 days from the closing date of bids.
23. Any addition made in the terms & conditions in the NIT advertised will be implemented as per KPPRA Rules.

Note: Work order to the successful contractors/ bidders will be issued subject to availability of funds.
