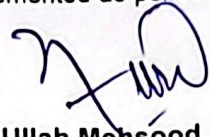

Terms and Conditions:

- Bid Solicitation Document scan be downloaded from the EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website (www.kppra.gov.pk) after the publication of NIT. The bid documents will be filled neatly and a clear scan copy of the same shall be uploaded at the time of apply through EPADS. Cutting and overwriting in the bid documents shall not be acceptable.
- The last date & time of submission of electronic bid is **19th August, 2026 at 12:30 PM**, while the date and time of Opening of electronic bid is **19th August, 2026 at 02:00 PM**.
- The bid securities must be prepared in favor of the **Assistant Director, LG & RDD Tehsil HeadQuarter District Kurram**. A scan copy of the bid security shall be uploaded on the EPAD system at the time of bid submission and the same shall must be delivered to **office of the Assistant Director, LG&RDD, Tehsil Head Quarter Upper Kurram District Kurram** through registered mail/courier up to closing time as mentioned above.
- The bid securities for the work must be prepared after publishing of NIT and before closing time of electronic bid.
- Rates may be offered as % above or % below or At-Par on Engineer Estimates.
- Last date and time for Online Clarification is **12:00 PM on 18th August, 2026**.
- Matters related to Bid Security and Additional Security shall be dealt in accordance with KPPRA Notification No. S.R.O.(29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional Security shall be in accordance with KPPRA Notification No. S.R.O.(14)/Vol: 1-24/2021-22 dated 10th May, 2022.
- In case of rates more than 20% below, a detailed rate analysis must be uploaded/submitted along with valid and justifiable supporting documentation.
- The contractor or his representative can be present at time of opening of electronic bids opening.
- In case of tie/draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
- The eligible contractors/firms must have the relevant codes as per PEC.
- Any bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate /take action in llight of approved procedure/mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
- Bids will remain valid for **90 days** from the closing date of bids.
- Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
