TERMS & CONDITIONS:

- Interested and eligible bidders/contractors should register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> before submitting their bids on EPADS, under the Single Stage two Envelope method of KPPRA Rules 2014.
- The Bids (Technical / Financial) must be submitted / uploaded on EPADS on or before, 20th August 2026 till 11:00 am. The technical bids of participating bidders submitted through EPADS will be accepted and opened publicly on 20th August 2026 till 11:30 am at WSSP Conference Room. Whereas the financial bids of the technically qualified bidders will be opened on date and at the time announced after completion of technical evaluation.
- ORIGINAL two (2%) CDR and additional security (if any) as per KPPRA Rule of the total bid price in the name of “WSSP Contractor Securities” and an affidavit regarding original 02% CDR shall be separately sealed and put in separate envelopes and marked as “CDR and affidavit for Work “CONSTRUCTION OF WATER AND SANITATION SERVICE (WSSP) HEAD OFFICE BUILDING”. The envelopes

containing the ORIGINAL CDR and an affidavit regarding 02% CDR will be put in one large, sealed envelope and shall reach on below given address before the closing date and time.

4. Bids submitted/uploaded through EPADS (only) will be considered and accepted. It is the sole responsibility of the bidder to ensure that all the required documents are correctly uploaded and clearly legible. Failure to submit any required document or submission of incomplete, illegible or corrupted files shall render the bid non-responsive. No hard copies of the bid documents shall be required / accepted.
5. The interested bidders should deposit a fee of PKR 5000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase 3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers. The deposit slip fee amounting to Rs. 5000/- must be submitted before the closing date and time along with CDR.
6. A pre-bid meeting will be held on Monday 10 th August 2026 at 3:00 pm at WSSP Conference room as per address mentioned below.
7. Subcontracting/subletting of works is not allowed. If the contractor /firm is found to be involved in subcontracting after the award of the Contract (wholly or partially). The contract awarded will be cancelled immediately. The bid security will be forfeited, and the firm / Contractor will be recommended to PEC for blacklisting / debarment.
8. The bid must be stamped and signed by an authorized person of the firm. All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time.
9. Any disfiguring/overwriting, or manipulation in the uploaded tender/BOQ shall be liable to rejection. Other terms and conditions are available in the BSD.
