The bidders shall upload all the relevant/mandatory documents along with the bid security on the EPADS. Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.

The bidders are required to submit only bid security (in original) and physical from in the form of Call Deposit Receipt (CDR) in the name of "Medical Superintendent, DHQ Hospital, Tank".

The technical bids will be opened in the presence of the bidders or their authorized representatives who choose to attend. However, the physical presence of the bidders is optional, and the bid opening process will proceed as per scheduled time regardless of their presence, provided their bids and original Bid Security (CDR) are successfully received before the deadline.
