TERMS AND CONDITIONS

- Electronic bidding will be online through EPADS-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of Irrigation Department i.e. www.irrigation.gkp.kp, moreover a complete set of bid solicitation documents may be obtained by the contractor or their representative having valid authority letter on submission of written application from office of the undersigned in shape of Call Deposit (CDR) nonrefundable fees of

5% @ of estimated cost otherwise bid submitted without these documents will be considered as non-responsive.

2. The contractors quoting their bids upto 10% below on Engineer estimate would submit 2% CDR (in Original), the bidder who submit bid from 10-20% below would additionally submit 8% CDR (in Original) along with the stamp duty separately in shape of call deposit (CDR) (in Original) in the name of procuring entity (**through register courier**) to the office of Assistant Engineer Irrigation Sub Division Wazir Bannu, Miranshah Road District Bannu before closing date and time. The contractors who fail to submit the above conditions would be considered as non-responsive.
3. As Per KAPRA Notification S.R.O (29)/Vol:1-40/2025-26, Dated: 29-10-2025, all conditions of the notification regarding debarred and blacklisting would be applicable.
4. KPPRA Notification No. KP-PPRA/Enf/W.G/MoM/24-82/2025-26 Dated: 20-05-2026, shall be applicable.
5. Electronic bidding shall be done on "above/below system" on BOQ/Engineer's estimate, based on MRS 2025 (1st BI Annual). Only two digits after the decimal point shall be considered for evaluation purpose.
6. Bidding documents can be downloaded from the official EPADS website (i.e., eprocure.gov.pk) after publishing the NIT. The BSD must be filled neatly, and a clear scanned copy of the same must be uploaded at the time of application (bid submission) through EPADS.
7. Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable. And will lead to disqualification and the Contractor will be considered non responsive.
8. The venue for bid submission and bid opening is the office of Assistant Engineer, Irrigation Sub Division Wazir Bannu, District Bannu.
9. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2018 (Khyber Pakhtunkhwa Act. XXI of 2013).
10. All Federal and Provincial taxes/duties shall be deducted from the bills of the contractors at prescribed rates as per Government Policy issued from time to time.
11. Any bidder who provided incorrect information shall stand disqualified as per KPPRA Act Section 29 (I) rule (43).
12. The defect liability period for 02 Years (all allied accessories) & Warranty for Solar Panel for 20 Years and shall be commence from the date of commissioning for each work.
13. The procuring entity has the authority to reject any bid or all bids assigning valid reasons.
14. All the prevailing KPPRA rules/Act and other Govt. notifications will be applicable issued from time to time.
15. The bids if received to the procuring entity, unsealed will be rejected.
16. Pre-bid meeting will be held on **12-08-2026 at 11:00 AM** in office of the Assistant Engineer, Irrigation Sub Division Wazir Bannu, District Bannu.
