Key Instructions:

- The entire bidding process will be carried out through the EPADS KP-PPRA portal: <https://portalkp.eprocure.gov.pk>
- The Bid Solicitation Documents (BSDs) are available on the EPADS portal for download by registered firms.
- Bid documents must be uploaded via the EPADS portal in accordance with the system's requirements. If bidders do not submit their bids via EPADS their bids will not be accepted. While preparing the bidding documents, bidders must ensure proper pagination and sequencing in accordance with the Bid Solicitation Documents (BSDs). The purchase committee may require bidders to present all original / physical bid documents-complementary to the files uploaded via the EPADS portal for verification and official record purpose.
- The bidders are required to submit only bids security (in original) and physical form in the form of call deposit receipt (CDR) against mentioned in the tender in the name of Medical Superintendent of DHQ Hospital Haripur.
- A **Call Deposit Receipt (CDR)** equal to the prescribed amount as shown above must be submitted in original (hard copy) to the Office of the Medical Superintendent, DHQ Hospital Haripur, before 10:30 AM on 31-08-2026.
- Bids will be opened on 31-08-2026 at 11:00 AM in the presence of bidders or their authorized representatives (if any) at the office of the undersigned.
- The rate approved shall stand effective till 30/06/2027, read with KPPRA Rules 2014/2022, Rule 31-a.
- All government taxes will be applied as per applicable laws. All bidders must be registered with FBR, and (where applicable). All Bidders shall be on the FBR-ATL.
- All bidders are directed to thoroughly read the BSDs of their particular category of applying and comply with the criteria mentioned in the BSDs, any deviation from can lead to cancellation of bid.
- The bidder, if declared successful as a winner, will be bound to ensure the supply to the Main Store within the stipulated period, otherwise penalty and other action as per Govt; rules will be imposed upon.
- The hospital reserves the right to verify all the documents and certificates of the bidders. If any document is found fake or forged, the bidder will be declared non-responsive, and strict legal action will be taken, which may include forfeiture of CDR and other penalties as per KPPRA Rules and other Criminal Codes for the time being in force.
- The procuring entity under rule 47 may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, after intimation to the bidders.
