- Instructions to bidders can be obtained from the office on any working day or downloaded from C&W web site (www.cwd.gkp.pk) before submission date / time.
- The bidders shall submit bid security and, where applicable, additional security in accordance with KPPRA Notification No. S.R.O. (14)/Vol:1-24/2021-22/6058-71 dated 10 May 2022.
- Submission, retention and enforcement of bid security and additional security instruments shall be governed by the Khyber Pakhtunkhwa Public Procurement (Bid Security Instrument Submission and Enforcement) Regulations, 2025, notified vide No. S.R.O. (29)/Vol:1-40/2025-26/699-711 dated 29 October 2025, which is reproduced as below.

All bidders shall enter the details of bid security and, where applicable, the additional security instrument in the E-PAK Acquisition and Disposal System (EPADS) at the time of bid submission. The original bid security and additional security instruments, detail of which have already been entered in EPADS, shall be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instrument of all bidders until signing of the Contract with the best evaluated bidder or till the bid validity period whichever is earlier.

i. In case of failure to submit the original bid security and additional security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) year.

ii. In the case of violation for second time, blacklist him for a minimum period of three (03) years in accordance with Section 29 of the KPPRA Act read with Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.

- A Copy of the Technical Proposals in the required format is mandatory and to be uploaded as part of E-Pak Acquisition & Disposal System (EPADS) before submitting Financial Bids, in case of incomplete or failure to upload Technical Proposals complete in all aspects on EPADS, the bid shall be considered as Non-Responsive.
- Complete detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number (s) and Date (s) must be submitted electronically along with E - Bid on the E-Pak Acquisition & Disposal System (EPADS).

5. All Bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
6. The financial bids of technically responsive bidders shall be opened publicly on the date, time and venue communicated through EPADS and to the concerned bidders after completion and approval of the technical evaluation.
7. Venue of Bids opening is "Office of the Executive Engineer C&W Division No. II Swat at Matta".
