3. Bid shall be stamped and signed by an authorized person of the firm before uploading on EPADS. All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with KPRA under Rule: 37A of KP-PPRA.
4. 2% Bid Security (CDR) from a Scheduled Bank of Pakistan, in favor of the “Divisional Forest Officer Mardan”, must be submitted in a sealed envelope marked as “Bid Security” before the closing date and time.
5. Any disfiguring/overwriting, or manipulation in the uploaded tender/BOQ shall be liable to rejection. Other terms and conditions are available in the BSD.
