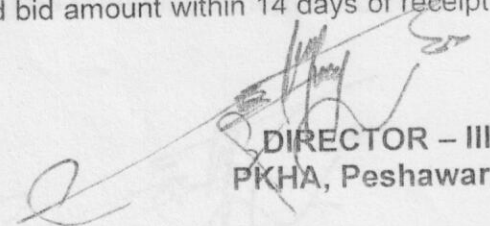

- The bidders are instructed to submit their bids through **E-PAD System** via <https://kp.eprocure.gov.pk>. In addition, **Call Deposits (in original) Copies of CNIC, PEC registration and KPRA (Active Status)** must also be submitted to the office of the Deputy Director (Procurement), PKHA, at Attached Departments Complex, Gate No. 5, Khyber Road, Peshawar. Bidders who fail to submit their original CDRs will be declared non-responsive and legal action may be initiated against them.
- Period for commencement and completion will be intimated in the work orders.
- Call Deposit / Bank Guarantees of scheduled banks in favor of the **Managing Director PKHA** only shall be accepted.

INSTRUCTIONS TO BIDDERS
(Single Stage One Envelop Procedure)

1. Bids will be opened on EPAD System after 30 minutes of closing time, in the presence of procurement committee and bidders / their representatives who chose to be present.
2. The bidders quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate till the closing time.
3. The bidders quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
4. A bidder quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
5. In case detailed rate analysis submitted with the bids is, in view of this Authority, not convincing, the MD-PKHA may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
6. The bidders are required to quote their rates "ABOVE / BELOW / AT PAR" for both priced BOQ / Engineer Estimate based on **MRS-2025 (1st Bi-Annual)** and NSI Items as well.
7. Any bidder who provides incorrect information shall stand disqualified & shall be debarred.
8. Electronic Bids validity period is 90-days.
9. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through Open Draw.
10. The MD-PKHA has the authority to reject any bid or all the bids assigning cogent reasons.
11. Bid security of the 1st, 2nd and 3rd lowest bidders for each work will be retained till the approval of bids.
12. The successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sales tax & any other at prevailing rates.
13. The successful bidder, whose accepted bid amount is Rs. 20.000 million or more shall be required to deposit Performance Security equivalent to 10% of the accepted bid amount within 14 days of receipt of the Letter of Acceptance (LOA).
