Executive Engineer Irrigation Division Bajaur, Government of Khyber Pakhtunkhwa, invites electronic Bids on EPAD system from the eligible firm s/ contractors in accordance with Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) rules 2014 on single stage single envelop system. TERMS AND CONDITIONS

1. Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work can be downloaded from the Irrigation Department and or Khyber Pakhtunkhwa Public Procurement Regulatory Authority websites (www.irrigation.gkp.pk) (www.kppra.gov.pk).

2. The bidder shall submit with requisite documents through reliable/registered courier service on the following address “**Executive Engineer, Irrigation Division Bajaur**” on or before the deadline along with 2% bid security of the estimated cost + stamp duty in shape of call deposit CDR (In Original) in sealed envelope. The bidder who’s bid in hard form or in EPAD is not available would be non-responsible. Each page of bidding documents must be stamped and signed and Numbered by the contractor.
3. Non-refundable bidding entry fee @0.03% of the estimated cost in shape of Call Deposit only/separately may be furnished (in Original) to this office in the name of Executive Engineer, Irrigation Division Bajaur, no cash payment will be acceptable.
4. Complete details of the bid security in shape of CDR i.e. Bank Name, CDR Number and Date (s) must be submitted electronically along with the EPADS system. Call deposit of schedule banks shall be acceptable. No bank cheque or pay order shall be acceptable.
5. Bid security of all bidders will be retained by the procuring entity till approval of the bid by the competent authority.
6. Any bidder who provided incorrect information shall stand disqualified as per KPPRA Act, Section 29 (1) rule (43).
7. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority.
8. As Per KPPRA Notification No. S.R.O (29) /Vol: 1-40/2025-26, dated: 29-10-2025 all bidders are required to submit the bid security and the additional security/differential, as already entered in EPADS, to the procuring entity before the closing date and time. In case of failure, the bidder shall be debarred for one year. Furthermore, upon a second violation, the bidder shall be blacklisted for a minimum period of three years.
9. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
10. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
11. Pre-Bid meeting will be held on **26-08-2026 at 11:00 A.M** in the office of the Executive Engineer, irrigation Division Bajaur.
12. The last date & time for Submission of the Bid along with relevant documents is **02-09-2026 upto 12:00 P.M** which will be opened on the same day at **01:00 P.M** in the office of Executive Engineer, Irrigation Division Bajaur, in the presence of contractors or their authorized representatives who wish to attend.
13. Bidding documents can be downloaded from the official EPADS website (i.e. eprocure.gov.pk) after publishing the NIT. The BSD must be filled neatly, and a clear scanned copy of the same must be uploaded at the time of application (Bid submission) through EPADS.
14. Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable. Any mismatch between the scanned copies submitted through EPADS and those submit in hard form will lead to disqualification.
15. All Govt. Notifications/Rules/Taxes updated from time to time shall be applicable.
16. The procuring entity has authority to reject any bid or all bids assigning valid reasons.
