

TENDER NOTICE

Government Maternity Hospital (GMH), Peshawar invites Electronic Bids via EPADS through single stage single envelope from the bidders registered with Income Tax, Sales Tax Departments and Khyber Pakhtunkhwa Revenue Authority (KPRA) for the supply of following items for the current financial year (CFY) 2026-27. Complete quotations in all aspects shall be submitted via EPADS before **10-09-2026** which shall be opened electronically at 10:30 AM on the same day in the presence of the members of the Purchase Committee and bidders or their representatives in the office of the Medical Superintendent, Government Maternity Hospital, Peshawar.

TERMS AND CONDITIONS:

1. All bidders must apply through EPADS before the mentioned closing date and time otherwise their bids shall not be considered and shall be treated as non-responsive.
2. Procurement shall be carried out through KPPRA Rules 2014, e-PADS Regulations 2025 and other relevant rules.
3. In addition to the online EPADS submission, Bid Security in the form of Call Deposit Receipt (CDR) properly sealed and marked confidential shall be submitted to the Office of the Medical Superintendent, Government Maternity Hospital, Peshawar before closing time and date, otherwise the bids shall be rejected.
4. The Bid Security only in the shape of Call Deposit issued by the scheduled Bank from the respective Bank Account of the firm in the favour of the Medical Superintendent, Government Maternity Hospital, Peshawar shall be acceptable. Any bid submitted otherwise shall be declared non-responsive.
5. Preference shall be given to the local firm/supplier.
6. All bidders are required to fulfill mandatory requirements as prescribed in the Bid Solicitation Document (BSD) otherwise bids shall stand non-responsive.

7. Bidders shall have a valid Income Tax, Sales Tax Certificate and KPRA Certificate / Registration (where applicable).
8. Local purchase of medicines shall be made on the basis of the highest discount rate offered. Preference shall be given to the nearest pharmacy / medical store. The successful bidder shall ensure delivery within 2 hours and maintain 24/7 availability.
9. The bidders are requested to provide their best and final unit prices as per specifications as mentioned in other terms and condition and no negotiations in the process are allowed.
10. The bid must be valid for 60-days after its submission.
11. Bids / quotations having alternate rates shall be rejected.
12. Bids submitted on the EPADS without specifications shall be rejected.
13. Rates shall be valid till 30-06-2027.
14. Bid documents uploaded on the EPADS shall bear the stamp and signature of the authorized representative of the firm. The name, address and phone/cell number of the firm's focal person shall be clearly mentioned in the e-bids.
15. The successful bidder shall sign an agreement deal with the Medical Superintendent, Government Maternity Hospital, Peshawar.
16. If the evaluated bid cost of two or more than two bidders are equal then the successful bid shall be declared through open draw in the presence of intended bidders.
17. Call deposit shall be attached by the name of Medical Superintendent, Government Maternity Hospital, Peshawar.
18. The supply shall be completed within the stipulated period as specified in the supply orders.
19. The bidders who have uploaded their bids under the wrong head on the EPADS shall be rejected.
20. The Competent Authority has the right to accept or reject any or all bids as per KPPRA Rules.
21. The bid shall be rejected in case of missing any of the above mentioned and other prescribed terms and condition.
22. The selection of the bidder shall be based on quality. The bidder offering the lowest evaluated price while meeting the required quality and specifications shall be selected.
