

**INVITATION FOR BIDS (IFB) UNDER NATIONAL COMPETITIVE BIDDING (NCB) FOR
THE FINANCIAL YEAR 2026-27**

The Medical Superintendent, THQ Category-C Hospital Samar Bagh, District Lower Dir, invites sealed bids through the e-Pak Acquisition and Disposal System (e-PADS) under National Competitive Bidding (NCB) from eligible manufacturers, importers, distributors, suppliers, contractors, authorized dealers and sole agents for the procurement of the following goods for the Financial Year 2026-27. The procurement shall be conducted through the Single Stage – One Envelope procedure in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement of Goods, Works and Services Rules, 2014.

TERMS AND CONDITIONS

- The contract/rates shall remain valid up to **30 June 2027**, or until the award of a subsequent contract under the applicable rules, whichever is later.
- The Bidding Documents containing detailed specifications, eligibility criteria, terms and conditions may be obtained from the office of the undersigned during working hours or downloaded from the e-PADS portal.
- Bids shall be prepared on the original letterhead of the bidding firm, duly signed and stamped on each page. Rates must be quoted in both figures and words. Handwritten, overwritten, or unauthenticated corrections shall render the bid liable to rejection.
- Bids shall be submitted electronically through e-PADS. In addition, a hard copy containing the original Bid Security (CDR), for record purposes only, must reach the office of the undersigned through Registered Post/GPO by 11:00 AM on 15 September 2026. Electronic bids shall be opened through the e-PADS system at 11:30 AM on the same day in the presence of the bidders or their authorized representatives who choose to attend.
- Wherever applicable, a valid Proprietary Certificate or Authorization Certificate issued by the manufacturer/distributor shall be attached with the bid.
- All applicable Government taxes and duties shall be deducted at source in accordance with the prevailing Government rules and regulations.
- All bidders must be registered with e-PADS, Federal Board of Revenue (FBR), and Khyber Pakhtunkhwa Revenue Authority (KPRA). The registrations shall be in the same legal entity name as that of the bidding firm.
- Bid Security in the form of Call Deposit Receipt (CDR), as specified against each item, shall be uploaded on the e-PADS portal, and the original CDR shall be submitted in favour of the Medical Superintendent, THQ Category-C Hospital Samar Bagh, District Lower Dir.
- For Serial Nos. 1 to 3, bidders shall possess a valid Category-A Drug Sale License.
- A separate bid shall be submitted for each item/service.
- The successful bidder shall execute a contract agreement on the prescribed value of Judicial E-Stamp Paper with the Medical Superintendent, THQ Category-C Hospital Samar Bagh, District Lower Dir.
- The Competent Authority reserves the right to accept or reject any or all bids in accordance with Rule 47 of the KPPRA Procurement of Goods, Works and Services Rules, 2014.
