The Project Director of Khyber Pakhtunkhwa Health Information and Service Delivery Unit (KP-HISDU), Health Department, Government of Khyber Pakhtunkhwa invites electronic bids from eligible and experienced contractors/firms, registered with the Pakistan Engineering Council (PEC) in C-6 or above category and duly registered with the Federal Board of Revenue (FBR) and Khyber Pakhtunkhwa Revenue Authority (KPRA), for execution and completion of the following works:

2. Contractors/firms that meet the prescribed eligibility and qualification criteria set forth in the Bid Solicitation Documents (BSDs) are encouraged to apply. 3. The procurement shall be conducted through Open Competitive Bidding/ Single Stage-Two Envelope procedure in accordance with the KPPRA Rules, 2014 and as outlined at Vol-I of the Bid Solicitation Documents.

4. The bidding procedure shall be conducted through the **e-PADS portal**. Bidders shall submit their bids electronically through e-PADS before the prescribed closing date and time.

Bid security at the rate 02% of the bid in the form of Call Deposit Receipt /Bank Guarantee issued by a scheduled bank in Pakistan in favor of the Project Director, KP-HISDU, Health Department, Government of Khyber Pakhtunkhwa, shall be submitted/uploaded in accordance with the bidding documents. The original bid security shall be furnished to the Procuring Entity within the prescribed time and before the bid closing date/time.

Bidders are strongly advised to visit and inspect the proposed site at Police Service Hospital, Peshawar, before submission of their bids to assess the existing site conditions, access arrangements, dimensions, existing installations and other conditions that may affect the execution of the works.
