TERMS AND CONDITIONS:

1. Bid Solicitation Documents (BSD's) which includes Bidding or Contract Data, Bill of Quantity (BOQ), & Criteria for Basic Eligibility, Technical Bid Evaluation & Financial Bid Evaluation, can be downloaded from the website of EPADS (kp.eprocure.gov.pk).
2. The last date and time for bid submission through EPADS is 18th September, 2026 at 12:00 PM. Bids will be opened at 12:30 PM on the same day in the presence of bidder's or their representatives or who opt to be attend.
3. The bidder shall submit/upload the technical and financial bids through EPADS before last date and time for submission of bid.
4. All bids must be accompanied by a bid security equal to 2% of the bid cost in shape of call deposit in the name of the Executive Engineer PHE Division DIKhan. Stamp Duty newly approved rates of Estimated amount in shape of call deposit is mandatory, failure of these CDRs will result in bid non-responsiveness/Bid Rejection. These CDR's shall be submitted in sealed envelope marked as financial Bid to the office of Executive Engineer PHE Division DIKhan.
5. Those contractors who applies online but failed to submit CDRs in hard form will be debarred.
6. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive.
7. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.
8. Clarifications, if any, may be asked by the bidder through EPADS.
9. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government/relevant laws/KPPRA as updated time to time, as mentioned in Bid Solicitation Document and in vogue.
