

NOTICE INVITING TENDER ON E-PAD SYSTEM

Directorate of Non Timber Forest Products, Khyber Pakhtunkhwa invites bid through EPADS, from the eligible contractors / firms in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 on "Single stage one envelope system under Rule 14 (2)(a) under ADP project titled **"CONSERVATION AND VALUE CHAIN DEVELOPMENT OF LOCAL HONEY BEES IN KHYBER PAKHTUNKHWA" 250522**" & ADP project titled **"DIVERSIFYING LIVELIHOOD OPPORTUNITIES THROUGH VALUE CHAIN DEVELOPMENT OF HIGH VALUES CHILGHOZA PINE FOREST IN KHYBER PAKHTUNKHWA 220053"**. TERMS & CONDITIONS:

1. The bidding documents can be downloaded from the official EPADS website i.e. (<https://eprocure.gov.pk/>) after the publishing NIT of KPPRA the BOQ will be filled neatly and clear and a scan copy of the same will be uploaded at the time of apply (Bid Submission) through E-PADS.
2. Proposals must be submitted through EPADS on or before 14th, September, 2026 till 11:00 AM, along with hard copies delivered to the office of the Director Non Timber Forest Products Khyber Pakhtunkhwa, Forest Department Shami Road, Peshawar which will be opened on the same day at 11:30 AM in the presence of the bidders or their authorized representatives who may wish to attend. The proposal must be signed and stamped by the authorized person of the firm.

3. 02% earnest money in shape of call deposit (in original) in the name of undersigned must be attached with the tender.
4. Incomplete bids / received after due date / time will not be entertained.
5. The procuring entity may reject all bids or any proposal / Bid at any time prior to the acceptance of a bid or proposals as per KPPRA Rule 47.
6. The procuring entity shall communicate reason / grounds for rejection to any contractor who submitted a bid or proposal as per KPPRA Rule 47.
7. All the testing material cost from the laboratory will be borne by the contractor as per Engineer advice.
8. Incomplete / conditional bids shall not be accepted.
9. The contractor offers their rates on above / below percentage as per items rates of BOQ will be considered in bidding competition.
10. The work will be started immediately after issuing work order & signing agreement. In case of absence of the contractor for non-starting of work, the contract will be cancelled and his security / earnest money will be forfeited to the Government.
11. All relevant taxes will be deducted from the contractor bills as per Government / KPPRA Rules.
12. In case of bid rate quoted by the bidder more than 10% below Engineer's estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the Engineer's estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below Engineer's estimate. The percentage of bid security shall be 2% of the Engineer's Estimate.
13. Tender documents of bidder if found bogus / false, documents will be rejected and their registration will stand cancelled / blacklisted in addition of forfeiture of Earnest Money.
14. Single-stage-one envelope bidding procedure containing envelop marked financial Proposal specified in KPPRA Rules 2014 shall be followed for receiving and processing the bids.
15. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
