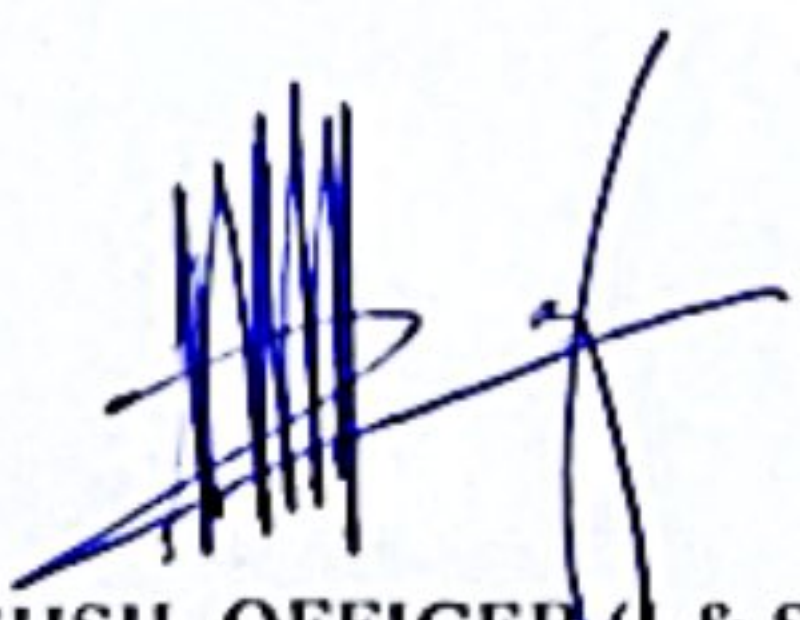

20. The Firm/Contractor should be registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue and having registered office, for the above developmental Schemes.
21. The bids, prepared in accordance with the instructions in the bidding documents, must be submitted on EPADS Up to 22/09/2026 at 12:15 PM Bids will be opened on the same day at 12:45 PM.
22. Tender will be based on (MRS-2025 1st BI-Annual) and contractors/Firms should quote their rate on percentage above/Below/at-par Basis.
23. All the contractors / Firms are bound to follow the KPPRA rules.
24. All the contractors / Firms must be registered with Khyber Pakhtunkhwa Revenue Authority and EPADS.
25. The following documents shall be attached with the bids. (i) Copy of enlistment with PEC and Local Council Board, Khyber Pakhtunkhwa, Peshawar for the year 2026-27. (ii) Photocopy of CNIC. (iii) Power of Attorney (if applicable). (iv) NTN/Income tax certificate and KPRA Registration. (v) tender form/BOQ/BSDs
26. Bidding documents, containing detailed terms and conditions, can be downloaded from <https://eprocure.gov.pk> free of cost.
27. Bids should be submitted electrically ONLY through EPADS. Manual submission of bids is NOT allowed. For registration and training on EPADS or in case of any technical difficulty in using EPADS, prospective bidders may contact Tehsil officer (I & S) office, Tehsil Municipal Administration Batkhela during Office hours.
28. The Electrical Works must be vetted from Assistant Engineer (Electrical) Local Council Board, Khyber Pakhtunkhwa, Peshawar before the execution of the works.
29. The Bid Security and additional security shall be submitted as per KPPRA notification No. S.R.O. (14)/Vol: 1-24/2021-22/6058-71 dated 10 May 2022.
30. Tender documents of bidder if found with bogus/false documents will be rejected and their registration shall stands cancelled/blacklisted in addition of forfeiture of earnest money.
31. The contractors/firms will have to start work immediately after the issuance of work orders, otherwise their call deposits will be forfeited and will not be allowed to participate in any tendering process.
32. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the person of persons signing the bid.
33. Cutting/Over writing/manipulation in Bid Solicitation Documents will not be acceptable. Any mismatching in scanned copies uploaded on EPADS and that submitted in hard will lead to disqualification and the same will be treated as non-responsive.
34. Original tender documents should reach to the office to Tehsil Municipal Administration Batkhela before the due date and time.
35. No tender is acceptable through Fax/by hand.
36. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically on EPADS and provided hard copy to this office.
37. Venue of Bids opening is office of the Tehsil Municipal Administration Batkhela.
38. In case of tie between bidders, successful bidder will be decided through Draw.
