

INVITATION FOR BIDS THROUGH E-PADS

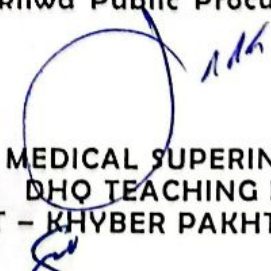
DHQ Teaching Hospital KDA Kohat intends to invite e-bids through E-Pak Acquisition and Disposal System (E-PADS), from firms/vendors/suppliers registered with Income Tax and Sales Tax Department, and having valid Drug Sale License under Khyber Pakhtunkhwa Drug Sales Rules 1982 (as amended in 2017), for Fair Price Pharmacy at DHQ teaching hospital KDA Kohat.

Bid Documents:

E-Bidding documents containing detailed terms and conditions, specification and requirements etc., are available for the registered bidders on E-PADS at <https://eprocure.gov.pk>

Terms and Conditions:

1. The bidding shall be conducted through SINGLE STAGE TWO ENVELOPES (TECHNICAL/FINANCIAL) in accordance with Rule 6(2)(b) under the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement Rules, 2014. Each envelope shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL".
2. E-Bids, prepared in accordance to the instructions contained in the bidding documents along with bid security, and required documents; must be submitted by using E-PADS on or before September 22, 2026 till 11:00 am. Manual bids shall not be accepted. Electronic Bids will be opened on the same day at 11:30 am.
3. Scanned copies of all documents shall be uploaded through E-PADS while submitting e-bid. However, bid security in form of Call Deposit Receipt amounting to Rs.2,000,000/- (in original) shall also be submitted in the office of the Medical Superintendent DHQ Teaching Hospital KDA Kohat, before closing time for submission of e-bid along with attested copies of other documents uploaded on E-PADS.
4. Bidders are required to submit all mandatory documents mentioned in subsequent sections. In case of failure to comply, the bidder shall be considered as non-responsive.
5. The income Tax, stamp duty and Professional Tax or any other Government tax will be charged as per rules.
6. The bidder must be registered with Khyber Pakhtunkhwa Revenue Authority.
7. Pre-bid Meeting will be held on September 14, 2026 at 11:30 am in the office of the Medical Superintendent DHQ Teaching Hospital KDA Kohat.
8. The approved rental rates and other services will remain valid until June 30, 2027, under KPPRA Rule 31(A) pertaining to framework contracts/agreements.
9. Offers received as per tender enquiry/bidding document, framed under KPPRA Act and Rules will be considered for the technical evaluation, otherwise it will be rejected and will not be entertained.
10. In case the contractor fails to execute the contract strictly in accordance with the terms & conditions laid down in the contract and/or Bidding Documents, the Call Deposit Receipt shall be forfeited and/or the firm will be blacklisted or both as the case may be.
11. The competent authority has the right to reject any or all bids by assigning reason under Rule 47 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014."
