Tenders based on MRS-2025 (1st Bi-Annual) are hereby, invites bids electronically through EPADS (E-Pak Acquisition and Disposal System) on single stage Two envelope procedure of KPPRA Rules 2014 from eligible firms / contractors registered with Pakistan Engineering Council in relevant category and enlisted with Local Council Board, Khyber Pakhtunkhwa, for the financial year 2026-27 on Specific field of specification for the following works under.

TERMS & CONDITIONS

1. A complete set of Bid Solicitation Documents (BSD), bidding documents (i/e including bidding documents, Bill Of Quantity, Criteria for i, Basic Eligibility/Mandatory, ii, Technical Bid Evaluation, iii, Financial Bid Evaluation etc) shall be download from the official websites of E-PAK Acquisition & Disposal system (EPADS of PPRA/KPPRA) at (<https://kp.eprocure.gov.pk>) and bidders are required to provide in original Pay Order/Demand Draft/Bank Slip in favour of TMO, TMA Jamrud amounting to Rs:15000 is documentation non-refundable fee against each work.
2. Interested bidders can obtain any further information / clarification from TMA Jamrud District Khyber.
3. Only eligible registered contractor can obtain tender's form.
4. Bid must be submit via <https://kp.eprocure.gov.pk> (scanned copy) on or before as per above mentioned schedule date & time against each work / contract and original bids (Financial & Technical) must be submitted in sealed envelope in the office of the Tehsil Municipal Officer, TMA Jamrud District Khyber.
5. The received technical bids shall be opened (Downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders of their representative who to be present.
6. The bid(s) received shall be evaluated as per the criteria mentioned in the bid solicitation documents.
7. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive
8. Date & Time of opening of Financial Bid shall be announced after evaluation of technical bids the financial bids of unqualified bidders shall be returned un-opened
9. The following documents must be attached with the bid such as (i) 2% earnest money in shape of original call deposit in the name of TMO, TMA Jamrud District Khyber from scheduled banks (ii). Enlistment copy of Local Council Board for the year 2026-27 (iii). Registration copy of Pakistan Engineering Council for 2026-27 and (iv). Copy of CNIC & (v). Copy of KPRA Registration for 2026-27 for each scheme in a separate envelope highlighting name of work (written over the envelope).
10. Sealed bids must be sent through registered courier service on or before dated fixed for opening and Technical will be opened on the same date at 02.00 PM in the presence of bidders by the tender committee. By hand submission of tender documents will not be accepted and such tender will not be entertained.
11. Bidder who submitted their financial bids without a valid call deposit will be barred from participating in bidding process for one year.
12. Submission of the bid by the contractor/firm implies that they are fully conversant with the site, scope of the work and terms and condition laid down in the tender/bid document.
13. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals the procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection or proposals as per KPPRA Rule 47.
14. The tender shall be processed according to "above / below system" based on market rate system.
15. The engineer estimate is framed on the current MRS 2025 (1st Bio-annual), If any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025/ prevailing market rates for NSI with the approval of the competent authority.
16. Tender forms and BOQs must be signed by the original contractor.
17. Bid security of some or all the bidders will be retained by the procuring entity till approval of tender / bid validity period.
18. The Department will not be bound to provide any machinery / testing laboratory and the total cost on it will be borne by the contractors themselves.
19. In case of bids become tie the award of contract shall be decided through evaluation which shall be bounded as final.
20. The bidders should be enlisted with the Khyber Pakhtunkhwa Revenue authority, as per KPPRA rules.
21. The bidders shall also submit their Bids (Hard Copy) with requisite documents i-e: - E-Tender Form, Signed BOQ, Active NTN Income Tax Certificate, PEC, LCB & KPRA Registration (Active), 2% earnest money, additional security if any (original in shape of CDR) & a certificate to the effect that there is no dispute of the Firm with any department

- involved litigation/arbitration on the left over incomplete projects and blacklisting on Stamp paper to the office of the undersigned through Registered Courier Service before the closing time. The Bids received by hand, not through Registered Courier Service and late shall not be entertained.
22. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bids as non-responsive without any forfeiture of bid securities and record reason thereof.
 23. Tender documents of bidder if found with bogus/false documents will be rejected and their registration shall stands cancelled/blacklisted in addition of forfeiture of earnest money.
 24. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the person of persons signing the bid.
 25. Cutting/Over writing/manipulation in Bid Solicitation Documents will not be acceptable. Any mismatching in scanned copies uploaded on EPADS and that submitted in hard will lead to disqualification and the same will be treated as non-responsive.
 26. In case of tie between bidders, successful bidders will be decided through Draw/toss.
 27. In case of Solar Project, only those contractors bid shall be entertained, whose Firms have been awarded specified code of Solar and having household solarization work experience and only approved / Registered Company Solar material will be installed.
 28. Audit and financial report of firm/for the last 03 years shall be submitted.
 29. Financial soundness and fresh bank statement showing Rs:50 million shall be submitted.
 30. Only up to Two Decimal Digits (0.00) will be considered for evaluation of the quoted Bid. If any document submitted along with bid documents found false bogus, the registration of the Contractor /Firm shall stand cancelled blacklisted.
 31. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security to the extent of 2% of Engineer Estimate only. The contractor quoting their bids more than 10% below up to 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security. If the bid is not accompanied by the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of TMA Jamrud District Khyber and the second lowest bidder and so on will be considered accordingly. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with **detailed rate analysis**. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of TMA Jamrud District Khyber and the 2nd lowest bidder and so on will be considered accordingly. It is to clarify that additional security will be provided in shape of call deposit in name of TMO TMA Jamrud District Khyber.
 32. Any addition made in the terms & conditions in the NIT advertisement will be implemented as per KPPRA Rules. Furthermore, all other terms & conditions / regulation notified by the KPPRA vide notification No. S.R.O(14)/Vol:1-24/2021-22 dated 10-05-2022/6058-71 in letter and spirit.
 33. In case of public holiday on date of Opening next day shall be considered as opening day and time of tender opening.
 34. Each Scheme will Cover 50 households,
