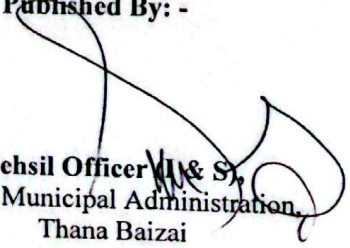

TERMS & CONDITIONS:

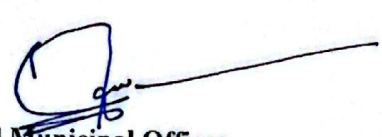
1. Bidding documents can be download from the official EPAD website i.e. (eprocure.gov.pk) after publishing NIT of KPPRA. The BSD will be filled neatly, clear and a scan copy of the same will be uploaded at the time of apply (Bid submission) through EPADS.
2. The award of contractor shall be on the basis of above / below engineer estimate on MRS-2025 (1st Bi Annual).
3. Earnest money & additional securities shall be prepared in light of KPPRA Notification No. S.RO(14)/Vol.1-24/2021-22 dated 10th May, 2022.
4. The Contractor shall quote their bid according to Notification No. PO(LG)/KP-PPRA/2026-27 dated 03/07/2026.
5. The bid Securities shall be in shape of call deposit receipt in favor of Procuring entity / TMO Thana Baizai.
6. Bids and Original Call Deposit received through fax or by hand will not be acceptable Sealed bids send through registered mail/ courier service should reached up to specified date and time as (mentioned above) and will be open in the presence of bidders or his representative by the Tender Committee.
7. These documents are compulsory with tender form i.e. (i) valid Registration of LCB (ii). Registration of KP Revenue Authority (iii). BOQ duly signed and stamp (iv). Original CDR & Additional Security (v). CNIC copy of MD / owner, (vi). Active NTN/Income Tax certificate.
8. Issuance of work orders / commencement of work on the above schemes shall be subject of availability of funds.
9. According to the Government Laws, all the taxes will be deducted.
10. Any cutting / over-writing on the BOQ will be liable to rejection of the tender and will be declared non-responsive.
11. In case of receiving equal offers, the award of contract shall be decided through a free toss which shall be final. Open draw will be conducted after verification of CDR's from Banks.
12. The procuring entity may reject all bids or proposals at any time to the acceptance of bids or proposals in light of KPPRA Rules-47.
13. The rules and regulation / instructions in future if issued by Provincial Government of Khyber Pakhtunkhwa, will be applicable.
14. Any addition made in terms and conditions in the NIT advertised in the newspaper or published on KPPRA website will be implemented as per KPPRA Rules.
