TERMS & CONDITIONS:

1. Bidding Documents, BOQs, SBDs, and instructions to Bidders can be downloaded from EPADS and KPPRA websites.
2. Bids shall be submitted through E-PADS before the closing date and time.
3. Original bid security and other documents, where required under rules, shall be submitted physically in a sealed envelope before opening time.
4. The Bid Security 2% and stamp duty according to the Government of Khyber Pakhtunkhwa Finance Act No. XIII of 2021, as well as the Board of Revenue & Estate Department letter No. AS (S) 3/240/2021-2/18744-874 dated 02-08-2021 shall be enclosed in the financial envelope.
5. Additional security, where applicable, shall be provided strictly in accordance with KPPRA rules and relevant notifications.
6. Last date & time for submission of the bid is **18-09-2026 at 12:00 (Noon)**.
7. Technical bids shall be opened on the same day at 1:00 PM in the presence of bidders or their authorised representatives who choose to attend.
8. Last time and date for clarification is up to **16-09-2026 at 3:00 P.M.**
9. Financial bids of only technically responsive bidders shall be opened on a date to be announced later.
10. **The following documents shall be uploaded/submitted as required:**

iii)	Valid enlistment Certificate from the Works Department.

vii)	Updated Audit Report Copy
viii)	The bidder will provide the certificate on Affidavit that the firm is not involved in any Litigation case with the PHE Division Kohistan Lower, duly attested by the Oath Commissioner.

ix)	The bidders already working with this Office shall attain the Performance Certificate from the concerned SDO, duly verified by the Executive Engineer of PHE Division Kohistan Lower, as per written request on the Company/Firm letterhead. The performance certificate from this office can be attained up to 10/09/2026 at 5:00 P.M.
x)	The bidder is required to provide work orders of previously performed works of similar nature and scope.
xi)	Bidders will provide a Bank Statement w.e.f 01-01-2024 to 31st of December 2025, duly stamped and signed by the concerned Bank.
xii)	Bidders will provide a separate Affidavit of Declaration on Stamp-Paper, duly attested by an Oath Commissioner, which shall be provided in the Technical Proposals Envelopes, wherein they declare that the required amount of CDR 2% bid security has been provided in the Financial Proposal Envelopes.
xiii)	The quoted rates must be clearly mentioned in the form of Financial Bids in words and figures on a duly signed and stamped document by bidders. Incomplete/over-writing/disfiguring, Mismatching, materially inaccurate and incomplete forms shall not be acceptable. The Form of Financial Bid uploaded on EPADS must be submitted in hard form enclosed in the Financial Bid.
xiv)	Tender fee @ 0.03% on bid cost in the shape of CDR attached with the Financial Proposal in the original.

11. Incomplete, conditional, unsigned or materially defective bids shall be considered non-responsive.
12. If any false information or tampering in documents is found, the bidder shall be proceeded against under the relevant laws/rules.
13. Bid securities shall remain valid and retained as per procurement rules.
14. All other terms & conditions shall be governed by KPPRA Rules, PEC regulations, Standard Bidding Documents and applicable laws.
15. Bids shall be evaluated strictly in accordance with the criteria given in the bidding documents.
16. The Procuring Entity reserves the right to accept or reject any bid(s) under the relevant provisions of KPPRA Rules.
17. Non-compliance with mandatory requirements of the NIT/bidding documents may render the bid non-responsive.
