

NOTICE INVITING HIRING OF CONSULTANCY SERVICES THROUGH EPADS

Public Health Engineering Division-II, Peshawar, Government of Khyber Pakhtunkhwa, intends to hire consultancy services (on Quality and Cost based through Single Stage Two Envelopes) for the following projects. 1. Technical and Financial Proposals (to be prepared by the interested consultant in accordance with RFP document), under Single Stage Two Envelopes procedure, shall be submitted through EPADS (file uploading system) on or before **17th September, 2026 at 1100 hours**.
2. Technical Proposals shall be downloaded from EPADS on/after **17th September, 2026 at 1100 hours** and shall be evaluated (in accordance with criteria mentioned in the RFP) by the Procuring Committee.
3. The interested consultant shall upload ‘bid declaration certificate’ on EPADS before the submission deadline. The bid declaration certificate shall possess a statement that in the event of award of consultancy services, the hired consultant shall submit a performance security/guarantee i.e., 10% of bid amount of the consultancy charges, in the shape of Call Deposit Receipt or Bank Guarantee (Schedule Banks of Pakistan) made in favour of “Executive Engineer, PHE Division-II, Peshawar”.
4. Financial Proposals shall be downloaded from EPADS by the Procuring Committee after the evaluation of Technical Proposals. The date of financial opening shall be announced/communicated to the consultant(s) after evaluation of technical proposals.
5. The financial proposal(s) of consultant(s) declared unqualified in the Technical Proposal Evaluation shall not be opened/downloaded.
6. A pre-bid meeting shall be held in the office of the Chief Engineer (Centre), Public Health Engineering Department, Khyber Pakhtunkhwa, at Plot 40, Sector B-II, Phase V, Hayatabad, Peshawar on **7th September, 2026 at 1100 hours**.

8. Incomplete or conditional application/proposals shall not be entertained.
