The interested bidders shall submit bid (s) by uploading scan copy of bid(s) on EPADS on or before the deadline mentioned above. The bidders shall upload all the relevant/mandatory documents along with the bid security on the EPADS. Bids received by hand, post, courier, e-mail, or fax shall NOT be accepted.

The bidders are required to submit **the original bid security (CDR)** in the name of 'District Health Officer, District Tank' which must reach this office by hand or courier before the closing deadline of bid submission on EPADS

Bid Security shall be equivalent to 2% of the total quoted bid price for the respective category.

Competent Authority reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KPPRA Rules 2014.

Important Note (Mandatory Clause): The successful bidder/supplier shall be bound to ensure the uninterrupted and continuous supply of ordered items to District Health Office District Tank under all circumstances. The delivery must not be delayed or suspended under any pretext, including the temporary non-availability or delay in the release of budgetary funds.
