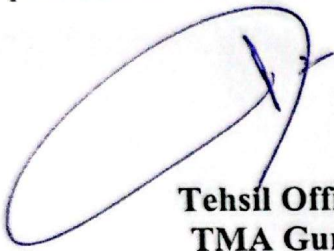

TERMS AND CONDITIONS:

1. Bidding documents can be downloaded from the official EPADS website i.e (eprocure.gov.pk) after publication in the National Dailies and KPPRA's website.
2. As per Clause 37(A) of KPPRA Rules, all bidders must be registered with Khyber Pakhtunkhwa Revenue Authority.
3. The bid documents along with original bid securities and detail rate analysis (If applicable) complete in all respect must be delivered through courier to the office of TMA Gumbat before closing time of bid.
4. The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e. Bid Security. Additional Security.
5. The tender shall be processed according to "Above/below system" based on the Market Rate System 2025.
6. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineering Estimate.
7. The contractors quoting their bids more than 10% below upto 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security, if the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
8. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and /or required amount of additional security, then the said bid shall be considered as non-responsive and debar the bidder for the period of 01 year. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
9. Mandatory documents for Solarization (specialization codes EE11 (i,ii,iii), Solarization codes EE11 (vi) General Electric works only ME06, ME07, Mechanical miscellaneous works. Certificate of sole proprietorship or Form-H as AoP or registration with SECP as PVT Limited Company, valid registration with Electrical Inspectorate of Khyber Pakhtunkhwa and valid registration with PPIB, formerly AEDB, Manufacturer Authorization & also Technical Compliance Sheet & the work shall be executed in accordance with the required revised provincial specifications.
10. Mandatory documents for s.no 11. specialization codes BC04 General Buildings & Maintenance, ME03 Lifts and Escalators Compressor Generators, EE02 Security, Safety Surveillance System, CE11(ix) General Building works & for serial no. 10 specialization code EE09, IT/Software Engineering & authorized supplier of furniture.
11. Mandatory documents i.e. Bid Security, BOQ duly signed and stamp, BSDs, LCB Enlistment, active NTN/Income Tax Certificate, valid PEC License, Active KPPRA Registration must be submitted electronically along with E-Bid on the E-PAD System.
12. In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convincing the head of Procuring Entity may declare such bid as non-responsive without forfeiture of bid securities and record reasons thereof.
13. The original bid security and additional security instruments of all bidders until signing of the contract with the best evaluated bidder of till the bid validity period whichever is earlier.
14. Work order will be issued on the availability of funds.
15. Any addition made in term and conditions in the NIT advertised in the newspaper will be implemented as per KPPRA Rules

16. If the evaluated electronic bid costs of two or more bidders are equal then the successful bidder will be declared through open draw.
17. All Federal and provincial duties / stamp duty and taxes including sales tax will be recoverable as per directives of the government issued from time to time.
18. Bank Guarantee shall not be acceptable as Earnest Money/Security Deposit against the tender. Only the prescribed form of Call Deposit Receipt (CDR) shall be accepted. Call deposit shall be in original otherwise it will not be acceptable.
19. The bidder shall submit the original Call Deposit Receipt (CDR) along with the bidding documents. Photocopies, scanned copies, or any other substitute shall not be acceptable. In case the original CDR is not provided, the bid shall be treated as non-responsive and dealt with in accordance with the applicable procurement rules/law.
