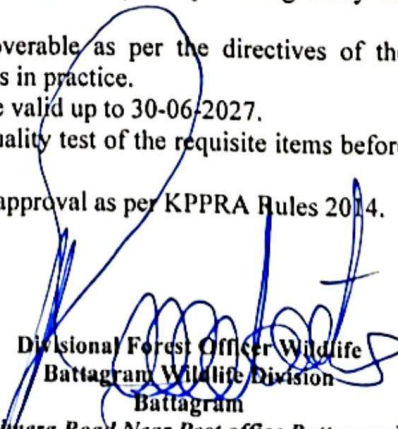


GOVERNMENT OF KHYBER PAKHTUNKHWA, WILDLIFE DEPARTMENT
NOTICE INVITING TENDER (EPADS)

The Divisional Forest Officer Battagram Wildlife Division invite Bids from eligible firms / bidders who are duly registered with Federal Board of Revenue (FBR) and Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) on Single Stage Single Envelope Procedure through EPADS for the following package under the project titled: **"10BTTP Phase-I Upscaling of Green Pakistan Program (Revised) (Wildlife Component)"**.

1. The Bidding documents can be downloaded for package from the official EPADS website i.e. (<https://portalkp.eprocure.gov.pk/>), this tender will also available on KPPRA website (<http://www.kppra.gov.pk/>). The Bid Soliciting Documents shall be filled neatly and a clear readable scan copy of the same shall be uploaded at the time of bid submission through EPADS.
2. The firms/contractors who wish to participate in the bidding process shall register themselves at the EPADS portal.
3. The bidders are required to fill online bids and upload the scan copies of the bid documents along with original tender form, original bid securities i.e. 2% bid security, submit hard copy of the same along with other relevant documents in sealed envelope to the office of DFO Wildlife **"Battagram Wildlife Division at Ajmera Road Near Post office Battagram"** before the closing date and stipulated time period for submission of bids.
4. The bids security shall be in the shape of CDR in favor of Divisional Forest Officer, Battagram Wildlife Division from the any scheduled bank of Pakistan.
5. Cutting and overwriting in the bidding documents shall not be acceptable. Any discrepancy between the scanned copies submitted through EPADS and the hard copies delivered to the Procuring Entity will result in disqualification and the bids will be considered as non-responsive.
6. **Interested firms/contractors must provide the following information with their application / Bidding documents:**
 - a. Photocopy of National Identity Card
 - b. Active registration status with the relevant tax authorities.
 - c. Affidavit of Non-involvement in any court case with the department.
 - d. Application must be signed by authorized person of the firm with official stamp.
 - e. 02% bid security.
7. The contractor/representative of contractors are invited to be present at the time of opening of electronic bids at the **Office of the DFO Wildlife Battagram Wildlife Division at Ajmera Road Near Post office Battagram.**
8. Bid securities of 1st, 2nd and 3rd lowest bidders will be retained by the procuring entity till approval of tenders.
9. All applicable taxes will be deducted and shall be recoverable as per the directives of the government and in accordance with the rules and regulations in practice.
10. The rates offered for procurements of requisite items will be valid up to 30-06-2027.
11. The Procuring Entity will conduct a thorough inspection/quality test of the requisite items before final payment.
12. The Procuring Entity may reject bid at any time prior to its approval as per KPPRA Rules 2014.
